ORDER RELATING TO THE TAKING OF MUSKRATS IN MINNESOTA
FOR THE YEAR 1929.


Pursuant to the provisions of Chapter 129,
Session Laws Minnesota 1925, and upon recommendation
of the Commissioner of Game and Fish of the State of
Minnesota, I, Theodore Christianson, as Governor of the
State of Minnesota, do hereby order as follows:


1. For the purposes of said act the state
shall be divided into two zones, the southern zone consist-
ing of that portion of the state lying south of the north
line of Township One Hundred Twenty-four (124) west of the
fifth principal meridian, and south of the north line of
Township 35, west of the fourth principal meridian, and the
northern zone consisting of all that portion of the state
lying north of the above described lines.

2. The taking of muskrats in any manner is
hereby prohibited in each of said zones except from the
period of time from noon March 1, 1929, to noon March 10,
1929, both inclusive, during which period the taking of
muskrats in each of said zones in such manner as is permitted
by law, is hereby permitted.

3. This order shall be effective for the year
1929 only and shall be subject to any orders providing
additional protection for muskrats in any specified portion
of the state pursuant to the provisions of General Statutes
1923, Section 5640 thereof.
