

Prince, Mayor of the city of south St. Paul, Dakota County, Minnesota, do hereby certify that the following proposed amendment to section one (1), Paragraph three (3) of Chapter Six (6) of the City Charter of the city of south St. Paul, was duly submitted to the voters of said city at a special election duly and legally called for that purpose, which election was duly and legally held in the city of South St. Paul, Minnesota on the 2nd day of April, 1929.

That said proposed amendment is as follows: -

"The City Recorder shall receive a salary of Two Thousand, (\$2,000.00) Dollars per annum, and such fees as are allowed by law. The duty is imposed on the city Council to provide funds to pay clerical help for the city Recorder not to exceed one Hundred (\$100.00) Dollars per month. such help shall be appointed by the City Recorder exclusively and shall be paid monthly.

All provisions of the city Charter inconsistent herewith and particularly the third Paragraph of Section Une, Chapter Six, are hereby repealed. Upon the passage of this amendment it shall take effect and be in force on and after May 1st, 1929".

That there were cast at said election 3249 votes. That there were cast in favor of said proposed amendment 1958 votes. That there were cast against said proposed amendment 1291 votes.

That more than three-fifths (3/5) of all the votes cast at said election were cast in favor of said proposed amendment.
