
EXTENDING ADDITIONAL PROTECTION TO MINNOWS IN HALE, CRYSTAL, MCKINNEY, FOREST, POKEGAMA, WABANA, CLEAR-WATER, MUSRAT, BOWSTRING, LITTLE AND BIG SAND LAKES, PORTAGE, BUCK, WILSON, BEADEYE, RUSH ISLAND, BASS, BEAVER, CEDAR, LITTLE AND BIG WHITEFISH LAKES, LITTLE AND BIG JESSIE LAKES, LITTLE AND BIG SPRING LAKES, COLES LAKE, RICE LAKE, AND THEIR INLETS AND OUTLETS AND ALL CONNECTING WATERS IN ITASCA COUNTY, MINNESOTA.


WHEREAS, it has been represented to the game and fish commissioner that minnows are in danger of undue depletion in the waters of Hale, Crystal, McKinney, Forest, Pokegama, Wabana, Clearwater, Mustrat, Bowstring, Little and Big Sand, Portage, Buck, Wilson, Beadeye, Rush Island, Bass, Beaver, Cedar, Little and Big Whitefish, Little and Big Jessie, Little and Big Spring, Coles, Rice Lakes and their inlets and outlets and all connecting waters in Itasca County, State of Minnesota, and

WHEREAS, the game and fish commissioner has investigated and has presented me with the results of his investigation, and has recommended that additional protection be given minnows in the above named lakes to prevent their undue depletion,

NOW, THEREFORE, I, Theodore Christianson, Governor of the State of Minnesota, by virtue of and pursuant to authority vested in me by Section 134, Chapter 400, S. L. Minnesota, 1929, Sec. 5640, G. S. 1923, do hereby order that no minnows be taken from the Hale, Crystal, McKinney, Forest, Pokegama, Wabana, Clearwater, Mustrat, Bowstring, Little and Big Sand, Portage, Buck, Wilson, Beadeye, Rush Island, Bass, Beaver, Cedar, Little and Big Whitefish, Little and Big Jessie, Little and Big Spring, Coles and Rice Lakes, and their inlets and outlets and all connecting waters in Itasca County, State of Minnesota, to be sold or bought and transported for commercial purposes during the seasons of 1929 and 1930.

This order shall remain in force until the close of the 1931 regular session of the legislature of the State of Minnesota unless sooner revoked or modified.
