The Village Council of the Village of Spooner in the County of Beltrami and State of Minnesota do hereby certify that a special election was duly held in said Village according to law on the 19th day of February 1927 between the hours of 12 o'clock P. M. and 4 o'clock P. M. of that day as appears by the minutes of election hereto attached.

That the votes cast at said election were duly canvassed by the said Village Council on the 20th day of February 1927 at a meeting of said Village Council held for that purpose.

That twenty-eight votes were cast at said election upon the question submitted; viz;- That the following territory comprising and embraced in the limits of the Village of Spooner be and are hereby set aside as a separate election and assessment district according to law;- the following were premises lying and being in the County of Beltrami and State of Minnesota;- Commencing at the Southwest corner post of Section one (1) Township one hundred sixty (160)N. Range thirty-one (31)E. 5th T. M.; thence easterly along the South line of said Section one (1) and continuing along the South Section line of Section six (6), Township one hundred sixty (160)N. Range thirty (30)E. to the center quarter post between Sections six (6) and seven (7) Township one hundred sixty (160)N. Range thirty (30)E.; thence northerly along the North and South quarter line of said Section six (6) to where the same intersects with Rainy River; thence westerly along the South Meander line of said Rainy River to where the same intersects with the East Meandered line of said Beaudette River; thence Southerly along the East Meandered line of said Beaudette River to where the same intersects with the East and West quarter line of Section two (2) Township one hundred sixty (160)N. Range thirty-one (31)E.; thence East along said quarter line to the quarter post between Sections one (1)

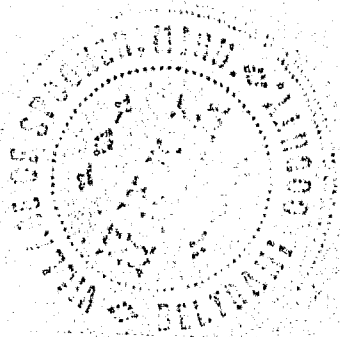
and two (2), Township one hundred sixty (160)N. Range Thirty-one (31)W.; thence southerly along the West Section line of said Section one (1) to the Southwest Corner post of beginning; The above including the following subdivisions of land according to the United States Government survey thereof;- Lots two (2), three (3), four (4), Seven (7) and eight (8) and the Southeast quarter of the Northwest quarter ($S.E.\frac{1}{4}$ of $N.W.\frac{1}{4}$) and the East half of the Southwest quarter ($E.\frac{1}{2}$ of the $S.W.\frac{1}{4}$) of Section six (6) Township one hundred sixty (160)N. Range Thirty (30)W. Lots one (1), two (2), Three (3) and five (5) of Township one hundred sixty one (161)N. Range Thirty-one (31)W. All of Section one (1) and Lots one (1), two (2) and six (6) and the Southeast quarter of the Northeast quarter ($SE\frac{1}{4}$ of $NE\frac{1}{4}$) of Section two (2) Township one hundred sixty (160)N. Range thirty-one (31)W.

That at said election twenty-seven (27) votes were cast in favor of said proposition so submitted as aforesaid and one (1) vote was cast against said proposition and the said Village Council of Spooner declared the proposition duly carried and the said real premises hereinbefore described and contained within the limits of the said Village of Spooner be and they hereby are set aside as a separate election and assessment district according to law.

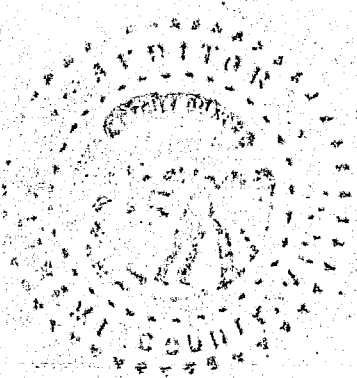
