We, the undersigned inspectors and residents upon the territory hereinafter described, and who were, by the Board of County Commissioners of St. Louis County, Minnesota, appointed as inspectors and to act as judges of the election ordered by the Board of County Commissioners for the determination of the incorporation of the said territory into a village to be known as the Village of Costin, do hereby certify and return:-

1- That the election to determine said proposed incorporation was held on Tuesday, the Second day of July, 1907, at the house of David Tousignant, located on the $W\frac{1}{2}$ of the $SE\frac{1}{4}$ of Section 4, in Township 58 North, Range 18 West of the Fourth Principal Meridian, in St. Louis County, Minnesota, the same being a part of the premises described in the notice of election and a part of the premises proposed to be incorporated into a village to be known as the Village of Costin.

2- That the polls were open for the purpose of voting at said election from nine o'clock in the morning, continuously until seven o'clock in the evening of said day.

RESOLVED, That Whereas, John A Beck and twenty-five others, residents and qualified voters upon the Southwest quarter, the West half of the Southeast quarter of Section four, the North half of the Northwest quarter and the Northwest quarter of the Northeast quarter of Section nine, in Township fifty-eight North, Range eighteen West, in St Louis County, Minnesota, desire to incorporate said territory as a village in the manner prescribed by law, and have petitioned the Board of County Commissioners of St Louis County, Minnesota, to call an election for the determination of such proposed incorporation, and have taken a census of the resident population upon said premises, as required by law; and said petition and census being in due form, Now Therefore be it RESOLVED, That said petition be and the same is hereby approved, and be it further RESOLVED, That the election for the determination of such proposed incorporation be held at the residence of David Tousignant, upon said above described premises, on July 2nd 1907. between the hours of nine o'clock in the forenoon and seven o'clock in the afternoon of said day, and that David Tousignant, John A Beck and John Lamminen, who are all residents of said territory, be and are hereby appointed as Judges of said election to conduct the same in accordance with the laws regulating the election of town officers.
