

MEMORANDUM OF AGREEMENT

Between the state of Minnesota, herein called the state,  
and Northwestern Stamp Works, a Minnesota corporation, herein called  
the contractor.

The state, through its commission of administration and  
finance, herein called the commission, having duly advertised for  
proposals for furnishing the state with approximately thirty thou-  
sand chauffeur's badges to be supplied in accordance with specific-  
ations dated June 10, 1950, a copy of which specifications are hereto  
annexed, and the contractor having submitted a proposal for the  
furnishing of those at a specified price per piece to be paid therefore,  
amounting approximately to \$1435.00, which amount for convenience is  
referred to herein as the purchase price, and the commission having  
accepted the proposal so submitted, copies of which proposal and the  
acceptance thereof are also hereto annexed and made a part of this  
agreement;

NOW, IT IS AGREED, that the contractor will enter at  
once upon the performance of the contract and will make and deliver  
to the state one thousand of these badges on or before September 1,  
1950, and the remainder thereof on or before November 15, 1950.

It is agreed that if the contractor shall fail in any  
respect to perform this agreement the state, at the option of the  
commission, may rescind upon notice and may purchase or procure such  
badges in such manner and from such person or persons as may be able  
to supply as speedily as possible thereafter, and may pay such price  
therefor as may be necessary to procure such articles and may charge  
to the account and recover from the contractor the difference between  
the price so paid therefor and the price fixed by this agreement, and  
the contractor shall pay to the state the amount of such difference  
on demand therefor.

Payment will be made in the usual course of state payment  
upon completion of deliveries as herein provided.

The contractor shall give bond to the state with sureties to satisfy acceptable to the commission in the full amount of the contract price, as stated herein, conditioned for the faithful performance of this agreement.

Gentlemen:

We are enclosing herewith our certified check in the amount of one hundred and fifty dollars (\$150.00), accompanied by our bid for approximately thirty thousand (50,000) badges.

We are pleased to quote you four and three-quarters cents ( $4\frac{3}{4}$ ) each net on the badges. The badges to be made as per sketch enclosed, nickel plated, as per your specifications, with the coat-of-arms of the State of Minnesota, and the numbers 1931 to indicate the year. Each badge having a serial number stamped on same, in addition there shall be the words "Licensed Chauffeur".

The badges shall all be enclosed in an envelope with a number on same corresponding with the serial number of the badge therein enclosed, and packed in cartons and arranged in numerical order in such a way that they be kept in order as they are being issued.

The workmanship and materials of the badges to be first-class in every respect, and guaranteed for one year used under ordinary conditions.

Delivery of the first one thousand (1000) can be made by September 1st, 1930, and the balance on or before November 15th, 1930. Additional or duplicate badges shall be furnished after that date during the remainder of the year 1930, and through-out the year 1931, as may be required, and delivered within three (3) days after receipt of same.

Proposals will be received by the Commissioner of Purchases, H. W. Austin, not later than June 26, 1930, 11 o'clock a. m. for furnishing the following specified badges 1.000.  
State Capitol, St. Paul, Minnesota. Proposals to be addressed to the Commissioner of Purchases and deposited with him at his office at room 10, State Capitol Building, St. Paul, at which time proposals will be opened and the contract awarded to the lowest bidder. The State reserves the right to reject any and all bids submitted.

There will be required approximately 30,000 badges. The exact number cannot be given, and bidders will specify a price per badge.

Each proposal must be accompanied by a certified check upon a state or national bank in the amount of one hundred fifty dollars (\$150.00), or such less amount as is equal to 10 per cent of the bid, payable to the state treasurer, the amount of such check to be forfeited to the state in case the successful bidder fails to enter into a contract and furnish bond within ten days after the award of the contract.

The successful bidder will be required to enter into a contract with the state for the manufacture and delivery of such plates, the form of such contract to be approved by the attorney general, and will be required to give a bond to the state with approved corporate surety in the amount of the contract price, conditioned upon the faithful performance of the contract.

SPECIFICATIONS

The badge shall be of brass metal, polished nickel plate, raised border, with heavy 1" pin back reinforced, which shall be embossed with the coat-of-arms of the State of Minnesota and the number "1930" to indicate the year. Each badge shall also bear the serial number to distinguish the licensee, stamped into the metal, and enameled in blue. In addition to the design, and these numbers, there shall be the words "LICENSED HAULER  
MINNESOTA."

In order that each may have a distinguishing number, the badges shall be numbered serially beginning with "1" and each badge shall be enclosed in a suitable envelope of good quality paper having printed on the outside the number corresponding with the serial number of the badge. Bidders are requested to submit a pen sketch, duplicate of the design herewith attached. Particular care is to be used in the sketching of the design as the final selection will depend a great deal on the appearance of the pen sketch. The badges shall be delivered in cartons and arranged in numerical order within the carton in such manner that they may be kept in order readily as they are being issued.

The materials and workmanship of the badges furnished under the contract shall be first class and fully equal to quality of badges now in use, and shall be guaranteed to last at least one year so used under ordinary conditions. The gauge of the metal to be used shall be No. 17 brass.

DELIVERY

The first one thousand (1000) badges shall be delivered not later than September 1, 1920, and the balance on or before November 10, 1920. Additional or duplicate badges shall be furnished after such date during the calendar of the year 1920 and throughout the year 1921 as the Secretary of State shall require and at the same price per badge as the original order.

Whereas promptness in the delivery of additional and duplicate badges will be an important consideration, each bidder will state in his bid the minimum time in which such duplicates and additional badges can be furnished after the order is placed by the Commissioner of Purchases.

The contract will contain a provision that if the contractor shall fail in any respect to perform the contract the State, at the option of the Commissioner of Purchases, may rescind and declare it null and void and the Commissioner of Purchases may purchase or procure such badges in such manner and from such person or persons as he deems proper, pay such price therefor as may be necessary in order to procure such articles or materials of the kind as nearly as practicable if the contractor shall fail to deliver as required, and may charge to the amount and recover from the contractor the difference between the price so paid therefor and the price stipulated in the contract and the amount of such difference shall be paid by the contractor to the State on demand.
