

IN RE: CENSUS INDEPENDENT SCHOOL DISTRICT
NO. 9, ITASCA COUNTY, MINNESOTA, TAKEN UNDER
THE PROVISIONS OF CHAPTER 417, LAWS OF 1921.

I, Odin H. Berg , being first duly sworn,
depose and say:

That prior to the 17th day of November, 1930,
this deponent was duly appointed by Mike Holm, Secretary of
the State of Minnesota, pursuant to Chapter 417, Laws of 1921,
to take a census of the residents of Independent School
District No. 9, Itasca County, Minnesota.

That thereafter this deponent agreed in writing
and under oath to perform his duties in connection with said
census faithfully and impartially and under the direction of
said secretary of state, as more fully appears from Exhibit
"A" hereto attached and made a part hereof.

That between the dates of November 17th, 1930,
and November 26th, 1930, all the inhabitants of said school
district, (with the exception of the Villages of Nashwauk and
Keewatin, for which the figures of the Federal Census of 1930
were used) were personally interviewed by this deponent; that a
separate card was prepared for each of the residents of said
district, containing the name of such resident, and also cont-
aining other data required by Mike Holm, Secretary of State;
that these cards were all prepared by this deponent and said
cards have been filed with Mike Holm, Secretary of State; that
the facts stated on said cards are true and reference is hereby
made thereto for that purpose.

That, as a result of said census, it appears
that there were on November 26th, 1930, One Hundred Forty
(140) residents of said school district residing outside the
corporate limits of the Villages of Nashwauk and Keewatin but
within the corporate limits of Independent School District No.9,
Itasca County, Minnesota.






