## ORDINANCE NO. 57

## th Orilnance To Change The Names -

 of the Village of Lesucur Center Home The Name "TeSucur Center" To the Name "Center"WHEREAS, on November 22, 1930, there was presented to the Village Council a petition signed by 159 legal voters of the village, praying that the name of the village be. changed from "LeSueur Center" to. the name "Center"; and,
WHEREAS, the council thereupon by a resolution duly adopted subxitted the question of such change of name to the voters of the village, to be voted thereon at the village election to be held on December $2 x$ 1930, and directed the Village Clerk to give due notice thereof, as required by the statute, and to have the question printed on the official ballot; and,

WHEREAS, notice that the said question was submitted to the voters of the village and would be voted upon at said election to be held. December 2,1930 , was duly given and posted by the Village Clerk, as required by law; and,
WHEREAS, the said question was duly printed upon the official ballot used at said election, in the follow. Ing language: "Shall the name of This village be changed from 'Le Sueur Center' to the name 'Center'; and,

WHEREAS, at said vilage election so held on December 2, 1930, there were cast 484 votes in all, of which 263 votes were in favor of such change and 192 votes were against such change; and;

WHEREAS, the majority of the totes só cast at satid election are in: favor of such change of name;
NOW, THEREFORE, pursuant to the authority so given,
The Village Council of the Village of LeSueur Center, Minnesota, do ordain as follows:
Sec. 1. That the name of this village be, and hereby is, changed from
? the name "LeSueur Center" to the name "Center".

Sec. 2. This ordinance shall take effect and be in force from and after December 15, 1030.
