

ORDINANCE NO. 118
AN ORDINANCE ANNEXING CER-
TAIN ADJACENT LAND TO THE
VILLAGE OF ARLINGTON, MIN-
NESOTA.

The Village Council of the Village of Arlington, Minnesota, do ordain as follows:

Section 1.

That the following described land, to-wit: Beginning at a point One Hundred Sixty-five (165) feet South (S) of the Southwest (SW) corner of Frenzel's Addition to the Village of Arlington, Sibley County, Minnesota, as marked by stone, and Thirty-five (35) feet west (W) of the Southwest (SW) corner of Block Sixteen (16) of Streissguth's Addition to said Village according to the plat of said addition of record in the Register of Deeds office of said county and thence running South (S) One Hundred Twenty (120) feet, thence East (E) One Hundred Thirty-five (135) feet, thence North (N) One Hundred Twenty (120) feet to South (S) line of Streissguth's said addition, thence running West (W) One Hundred Thirty-five (135) feet to point of beginning; abutting upon the incorporated village of Arlington, be and the same is hereby annexed to said village, and shall become a part of said village as effectually as if said land had been originally a part thereof.

Section 2.

This ordinance shall be in force and take effect from and after its adoption, and publication and a certified copy duly filed with the County Auditor and Secretary of State, as provided by law.

(1) Printed from the place from which it purports to be issued in the English language, and in column and sheet form equivalent in space to at least four pages, with five columns to the page, each seventeen and three-quarters inches long.

(2) Issued once each week from a known office established in such place for publication and equipped with skilled workmen and the necessary material for preparing and printing the same

(3) Made up to contain general and local news, comment and miscellany, not wholly duplicating any other publication, and not entirely made up of patents, plate matter and advertisements, or any or either of them.

(4) Circulated in and near its place of publication to the extent of at least two hundred and forty copies regularly delivered to paying subscribers, and that prior to the date of the

first publication of said Ordinance

the publisher or printer in charge of said newspaper having knowledge of the facts, filed in the office of the county auditor of said county of Sibley, State of Minnesota an affidavit showing the name and location of said newspaper and the existence of conditions constituting its qualifications as a legal newspaper as required and set forth in section 3 of chapter 484, Session Laws Minnesota, 1921.

That the following is a printed copy of the lower case alphabet from A to Z both inclusive, of the size and kind of type used in the composition, printing and publication of said legal advertisement hereunto attached, viz:

Further affiant saith not, save that this affidavit is made pursuant to section 4 of chapter 484, Session Laws Minnesota, 1921, and is intended to accompany the bill for the publication in said newspaper of the aforesaid legal advertisement.
