

Whereas, the Commissioner of Game and Fish of the Minnesota Department of Conservation, has investigated the necessity of providing additional protection for wood duck, greater or lesser yellowlegs, swan and eider duck, and has found that these species are in danger of undue depletion,

Therefore, I, Floyd B. Olson, Governor of the State of Minnesota, pursuant to authority vested in me by Section 5640, G. S. 1923, do hereby order that no wood duck, greater or lesser yellowlegs, swan and eider duck be taken or killed in this state during the year 1931.

This order shall remain in force until the close of the 1933 regular session of the Legislature of the State of Minnesota, unless sooner revoked or modified.
