Sir:

WHEREAS, on August 1st, 1931, there will be due and payable semi-annual interest on outstanding Rural Credit Bonds in the amount of \$624,565.04, and on August 15th, 1931, there will be due and payable semi-annual interest on outstanding Rural Credit Bonds in the amount of \$226,250.00, and whereas there is only \$840,793.04 available in the Rural Credit Interest Fund for that purpose, it is necessary and expedient to offer for sale certificate of indebtedness as provided by Sec. 12 of Chapter 225, Laws 1923, and acts amendatory thereof, in the sum of \$185,000.00 for the purpose of obtaining additional funds with which to meet such payments, and

WHEREAS, It is provided by Section 4 of said Chapter 225, Laws 1923, that before issuing any bonds or certificates it shall be the duty of the Department of Rural Credit to furnish to the Governor a financial statement showing the condition of the business of the Department.
