Certificate of County Auditor:

I, Mathew A. Spang, County Auditor in and for the County and State above named, do now make the following certificate; That at a certain time heretofore a certain petition was duly filed in my office and presented to the Board of County Commissioners of the County and State above named, praying for the incorporation of a certain territory as the "Village of Holman"; that thereafter the said Board of County Commissioners duly considered the said petition and adopted a certain resolution in the premises which said resolution granted the prayer of the said petition, and fixed a time and place for holding an election in the matter of the said incorporation, and which said resolution further named certain resident voters of the said territory as inspectors at said election; that thereafter due notice of the said election so provided for by the said resolution was properly given, and in the following manner, to-wit; there being no qualified newspaper published within the limits of the territory so proposed to be incorporated, the said notice of election was served by posting true and correct copies thereof in three public places, respectively, within the boundaries of the said territory; that thereafter the said election so provided for was duly held and a vote duly had and taken upon the said<sup>d</sup> proposition to so incorporate said "Village of Holman"; that thereafter a proper certificate was duly made in the premises reciting that at said election a

majority of votes had been cast in favor of the said proposed incorporation of the said "Village of Holman" and that subsequent to the making of said certificate the same together with all other papers and records affecting said proposed "Village of Holman", were duly filed in my office as one instrument; that in this connection reference is made to each of said papers and instruments as the same appear on file and of record in my said office;

That this writing certifies to all of the foregoing facts and further, that each of the respective papers hereinafter enumerated <sup>is</sup> each a true and correct copy of the original and all thereof as the same appear of record in my office, said papers being as follows, to-wit; petition for incorporating said Village, resolutions by the Board of County Commissioners granting the prayer of the said petition and fixing a time and place and naming inspectors for an election as to the incorporation of the said proposed Village, notice of election and proof of posting thereof, oaths of inspectors of election, ballot used at election, and verified certificates as to the manner of holding the said election and the result thereof, including with each paper such filing marks and endorsements as may appear thereon;

That the following described tract of land is situated

of Section twenty seven (27) in Township fifty six (56) North  
of Range twenty four (24) West 4th P.M., according to the  
United States government survey thereof:

That neither all nor any portion of the said described  
tract of land is now, or ever has been, incorporated as a  
municipality; that said tract has been platted into lots and  
blocks as "Holman", and with a view to village occupancy, as  
you petitioners are informed and verily believe: that said  
plat has heretofore been duly and legally certified, accord-  
ing to the laws of the State of Minnesota above mentioned,

Whereas, a certain petition for incorporating the Village of "Holman" has been duly presented to the Board of County Commissioners in and for the County of Itasca and State of Minnesota, it being shown by said petition that it is desired to incorporate a certain tract of land in said County already incorporated, to-wit, the Northwest quarter of the Northeast quarter (NW  $\frac{1}{4}$  NE  $\frac{1}{4}$ ) of Section Twenty-seven (27), Township Fifty-six (56) North, Range Twenty-four (24) West 4th P.
