P R O C L A M A T I O N

WHEREAS, the Labor Movement of America is today engaged in a campaign to bring aid to the workers of Great Britain who have united with their fellow citizens of all classes, parties and beliefs in a gallant defense of their heritage of freedom and democracy, and,

WHEREAS, it is fitting and proper that the spirit of fraternity and understanding among the wage earners of this country and other countries of the world in their mutual loyalty and devotion to democracy should be perpetual,

I, HAROLD E. STASSON, Governor of the State of Minnesota, do hereby designate and proclaim the week of

JULY 14 to JULY 20, 1943

as

AID BRITISH LABOR WEEK

and I further call upon the people of Minnesota to cooperate with the Labor Movement to ensure the success of this worthy program.

In witness whereof, I have hereunto set my hand and caused the Great Seal of the State of Minnesota to be affixed at the State Capitol in St. Paul this 9th
day of July, 1943.
