

ORDINANCE NUMBER SIX

An Ordinance Relating to the Extension of the Boundary Lines of the Village of Mahtomedi so as to Include and Annex certain Abutting Property to said Village.

Pursuant to that certain petition heretofore filed with the Village Council of the Village of Mahtomedi, Minnesota, requesting the inclusion and annexation of that certain tract of platted and unplatted land lying in Lincoln Township, Washington County, Minnesota, abutting said village, not exceeding two hundred acres, to the Village of Mahtomedi, and said petition being signed by the majority of the property owners of said tract of land,

The Council of the Village of Mahtomedi do ordain as follows:

Section 1. That the present village boundaries of the Village of Mahtomedi, Minnesota are hereby extended to include that certain tract of land heretofore abutting said village and lying and being in Section Twenty-nine (29), Township Thirty (30) North, of Range Twenty-one (21) West, Washington County, Minnesota, described as follows:

Commencing at a point on the West Line of the East half of the West half of Section Twenty-nine (29) where the Southwest corner of Lot One (1), Block Ten (10), Wildwood Manor abuts said line; thence east along the south line of said Lot One (1), Block Ten (10), Wildwood Manor to and across Kindross Road and continuing east along the south line of Lot Eighteen (18) and Lot Four (4) of Block Nine (9), Wildwood Manor to the center line of Derby Lane; thence north along the center line of Derby Lane to the south line of Lot Three (3), Block Seven (7), Wildwood Manor; thence east along the south line of Lot Three (3), Block Seven (7), Wildwood Manor to the center line of Wildwood Road; thence north along the center line of Wildwood Road to the intersection of the Stillwater Road and thence continuing north across the Stillwater Road to the Easterly boundary line of the paved Wildwood-Dellwood Highway and thence north along the Easterly boundary line of the paved Wildwood-Dellwood Highway to the East and West Center Line of Section Twenty-nine (29); thence west along the said East and West Center Line of Section Twenty-nine (29) to the West Line of the East Half of the West Half of Section Twenty-nine (29) and thence south along the said West Line of the East Half of the West Half of Section Twenty-nine (29) to the point of beginning.

And said territory is hereby made a part of the Village of Mahtomedi, Minnesota, as effectually as if the same had been originally a part of said village.

Section 2. This ordinance shall take effect and be in force upon the filing of a certified copy thereof both with the Register of Deeds of said Washington County and with the Secretary of State of the State of Minnesota and from and after its publication.
