

Certificate of Return of Special Election held at the Village of Elmore, Minnesota, on March 15th, 1932 on the Question as follows: "Shall the Village of Elmore, Faribault County, Minnesota, reincorporate under the provisions of Section 1110, Chapter 9 Mason's Minnesota Statutes for 1927"

We, the Judges of the Special Election aforesaid held at the Village of Elmore, Faribault County, Minnesota, between the hours of nine o'clock in the forenoon and five o'clock in the afternoon on the 15th day of March, 1932, hereby certify and return that the total number of persons present and who received ballots for the purpose of voting was eighty three; that the number of persons voting on said question was eighty three; that the total number of ballots marked "yes" was seventy five, and that the total number of ballots marked "NO" was eight; that the total number of ballots cast was eighty three.

## RESOLUTION

WHEREAS the Village of Elmore, Faribault County, Minnesota, did on the 23rd day of February A. D. 1932, pass a resolution calling for a special election for the reincorporation of said village of Elmore, under the provisions of Section 1110 Mason's Minnesota Statutes for the year 1927.

AND WHEREAS said resolution designated and fixed the 15th day of March, 1932, as the day of said special election, and the hours as between nine o'clock in the forenoon and five o'clock in the afternoon, for the time to submit to the electors of said Village of Elmore the proposition for reincorporating, and ordered that said election be held at the Village Hall in said Village of Elmore.

AND WHEREAS pursuant to said resolution notice was caused to be posted and published as required by law, setting forth the time and place of said election and question to be submitted to the voters at said election, and which said question was in words and figures as follows, to-wit:

"Shall the Village of Elmore, Faribault County, Minnesota, reincorporate under the provisions of Section 1110 Chapter 9 Mason's Minnesota Statutes for 1927".

AND WHEREAS pursuant to said resolution and said notice the said special election was held at the time and place aforesaid and the question above mentioned was voted upon at said special election,

AND WHEREAS the officers in charge of said election have filed with the Village Recorder of said Village their certificate showing result and made their return thereon, which said certificate and return shows that there were 75 ballots cast in favor of reincorporating, and 8 ballots cast against reincorporating.

AND WHEREAS from said certificate and return it appears that a majority of the votes cast at said election were in favor of reincorporating.

NOW THEREFORE, BE IT RESOLVED by the Village Council of the Village of Elmore, Faribault County, Minnesota, that a majority of the votes cast at the special election held on March 15th, 1932, as aforesaid were in favor of reincorporating said Village of Elmore.

BE IT FURTHER RESOLVED that said Village Council does herein and hereby declare that a majority of the votes cast at said special election were in the affirmative on the question submitted to the voters of said village.

BE IT FURTHER RESOLVED that said Village recorder be and he is hereby authorized and directed to file with the County Auditor of the County of Faribault and State of Minnesota, a certified copy of this resolution, and also to file with the Secretary of State of the State of Minnesota, a certified copy of this resolution.

We, the Village Council of the Village of Elmore, Faribault County, Minnesota, hereby certify to the County Auditor of said County and to the Secretary of State of said State, and to all to whom it may concern, that at the special election of said Village of Elmore, held at the Village Hall in said Village, being the place designated for said special election to be held by the Village Council, after due notice as provided by law, on the 15th day of March, 1932, O.H. Aamodt and Robert Emerson, duly qualified voters of said village of Elmore acting as judges of said election and C.M. Vicken, one of the qualified voters of said Village of Elmore acting as Clerk of said Election, each of whom within twelve days had been designated by the Village Council of said Village and appointed to act as judges and clerk of said election, and who were present at the hours of nine o'clock in the forenoon, and each of them having subscribed the oath to faithfully discharge the duties required of them at said election, and the said judges and clerk being duly qualified opened the polls by proclamation and the election proceeded by ballot without adjournment or intermission until closed.

The question voted upon at such election as stated in the notice thereof was:

"Shall the Village of Elmore, Faribault County, Minnesota, reincorporate under the provisions of Section 1110 Chapter 9 Mason's Minnesota Statutes for 1927"

At five o'clock in the afternoon of said day the polls were closed, proclamation thereof having been made by one of the judges thirty minutes prior thereto.

The judges then proceeded to publicly count and canvas the votes, and a true statement thereof was duly proclaimed to the voters by the Clerk who recorded the same in the Village Minute Book, as follows:

" STATEMENT OF THE RESULT OF CONVIASS "

The following is a true statement of the result of the count and canvass of the votes by ballot at the special election of the Village of Elmore, Faribault County, Minnesota, held March 15th, 1932, and proclaimed to the voters by the Clerk of said Election:

For reincorporation received Seventy-five votes

Against reincorporation received eight votes.

And we further certify that it was then and there voted that the Village of Elmore, Faribault County, Minnesota, was reincorporated by a majority of the electors of said Village of Elmore casting ballots on such question at said special election, that notice thereof had been duly given.

That thereafter and on to wit: the 22nd day of March 1932 the Village Council duly made and did declare the result by resolution and ordered a certified copy of the same to be filed with the County Auditor of said County, and another with the Secretary of State. That this certificate is made to comply with the requirements of Section 1110 Mason's Minnesota Statutes for the year 1927, and the said County Auditor is hereby requested to certify the same to the Secretary of State.


COUNTY OF FARIBAUT
