GENERAL ORDER NUMBER 4 FOR 1932,  
DELEGATING POWERS AND DUTIES TO  
THE DIRECTOR OF THE DIVISION OF  
DRAINAGE AND WATERS  
-----

I, William T. Cox, Commissioner of Conservation of the State of Minnesota, by virtue of the authority vested in me by law, and particularly by Session Laws of Minnesota for 1931, Chapter 186, do hereby order that all the powers and duties which immediately prior to the taking effect of said chapter were vested in or imposed upon the Commissioner of Drainage and Waters and the Department of Drainage and Waters, and which by said chapter were vested in or imposed upon the Commissioner of Conservation be and the same hereby are delegated to, vested in, and imposed upon E. V. Willard, as Director of the Division of Drainage and Waters of the Department of Conservation, and his successors in said office, and I do hereby authorize said E. V. Willard, as such director, and his successors in said office, to exercise said powers and perform said duties with like power and authority for all purposes as the Commissioner of Conservation might do if this order were not made.
