TO THE HONORABLE THE SUPREME COURT OF THE STATE OF MINNESOTA.

Under date of August 25, 1927 LaVallee Law Book Company entered into a written contract with the state for the publication of bound volumes of Minnesota state reports. This contract took effect on October 1, 1927, for a period of five years thereafter but contained a provision for renewal for an additional term of five years by mutual consent. The provision in the specifications in respect of the extension agreement is this:

"The extension agreement, if made, will consist of a proposal on the part of the contractor to continue the publication and sale of these reports for the additional period in accordance with the terms and conditions of the contract made hereunder, and the written acceptance of such proposal by the chief justice of the supreme court."

Under date of December 12, 1930, this contract, with the consent of the court, was assigned by the LaVallee Law Book Company to Review Publishing Company, and this last-named company has continued the publication and delivery of the required volumes in accordance with the conditions of the contract.

Now, in accordance with the specifications quoted above, we respectfully submit our proposal to continue this agreement in effect for an additional period of five years from October 1, 1932, and as an inducement to the consent

of the court to the proposed extension we offer to reduce the price twenty-five cents a volume, this reduction to apply to all volumes published under the contract.

If this proposal is agreeable to the court, we shall be pleased to have an indication of its acceptance.
