

CERTIFICATE OF CONSENT BY THE STATE OF MINNESOTA  
TO THE ACQUISITION OF LANDS BY THE UNITED STATES.

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, the Secretary of Agriculture of the United States, pursuant to the provisions of General Statutes of Minnesota 1923, sections 4 and 6, and to the acts of Congress hereinafter mentioned, has made application for the consent of the State of Minnesota to the acquisition by the United States of the lands hereinafter described under the authority of the Act of Congress of March 1, 1911, 36 Statutes at Large, page 961, as amended by the Act of Congress of June 7, 1924, 43 Statutes at Large, page 653, for certain national purposes therein specified, to-wit: The preservation of the navigability and the regulation of the flow of navigable streams and the production of timber and other purposes authorized by said acts;

AND WHEREAS, due proof has been made that the title to said lands has duly vested in the United States for the purposes aforesaid;

NOW, THEREFORE, I, Floyd B. Olson, Governor of the State of Minnesota, pursuant to the authority vested in me by the statutes of the State of Minnesota aforesaid, do hereby certify that the State of Minnesota consents to the acquisition by the United States for the purposes aforesaid of the following described lands situated in the county of Cook, State of Minnesota, to-wit:



All upon the conditions prescribed by said statutes of the State of Minnesota, to-wit;

That the United States shall have jurisdiction over said lands so long as the United States shall own and hold the same for the national purposes aforesaid, subject to the right of the state to cause its civil and criminal process to be executed therein and to punish offenses against the laws of the state committed thereon.
