


APPOINTMENT OF ALFRED A. BURKHARDT AS
SPECIAL ATTORNEY FOR THE DEPARTMENT OF
CONSERVATION OF THE STATE OF MINNESOTA
TO EXAMINE ABSTRACTS OF TITLE.

I hereby appoint ALFRED A. BURKHARDT of Plainview, Minnesota, as special attorney for the Department of Conservation of the State of Minnesota to examine and render written opinions upon nineteen abstracts of title to lands to be acquired by the State of Minnesota, through that department, for the purpose of establishing and reforesting a large and small game public hunting ground and game refuge known as the Whitewater Game Refuge in Winona, Wabasha and Olmsted counties, Minnesota, and to perform such other services in connection therewith as may be required of him.

This appointment is made upon the written request and recommendation of the Department of Conservation of the State of Minnesota, and upon my judgment that the public welfare will be promoted thereby.

The compensation of said appointtee is hereby fixed at the rate of twenty-five cents per entry, including certificates for examining and rendering an opinion upon each abstract. Such compensation is to be paid out of the game and fish funds set apart for said Whitewater Game Refuge.
