

Ordinance No. 2.

An Ordinance extending the boundaries of the Village of New Munich so as to include the North East Quarter (NE 1/4) of section Nineteen (19) in township one hundred and twenty five (125) of Range thirty two (32) in the County of Stearns State of Minnesota as a part of and within the limits of said Village as aforesaid.

The Village Council of the Village of New Munich do ordain as follows:

Section 1. That the boundaries of the Village of New Munich be extended so as to include the following described real estate to-wit: except the North 1/2 of the North East Quarter (NE 1/4) of the North East Quarter (NE 1/4) of section Nineteen (19) in Township One hundred and twenty five of Range thirty two (32) lying and being situated in the County of Stearns and State of Minnesota, and that said described tract of land as aforesaid be included and comprise and be a part of the Village of New Munich.

Section 2. This ordinance shall take effect and be in force from and after its adoption, publication and after a certified copy thereof is filed with the Secretary of State.

AFFIDAVIT OF PUBLICATION.

Steffen, and being duly sworn deposes and says that he is, and during all the times hereinafter mentioned, was the publisher, printer and manager of THE MELROSE BEACON, a legal newspaper printed and published in the City of Melrose, in said Stearns County, on Friday in each week, and that he knows of his own knowledge that the printed

date of the first publication of said Ordinance; that the publisher of said newspaper on the twentieth day of December, 1907, filed with the County Auditor in and for said County of Stearns an affidavit setting forth the facts required by section 5515 of the Revised Laws, 1905, of Minnesota and all the acts and parts of acts amendatory thereof and supplementary thereto.
