

ORDINANCE NO. 38

An Ordinance to Annex and Incorporate Certain Lands Adjoining the Corporate Limits of the Village of Appleton, Swift County, Minnesota, to Said Village:

Whereas there has been filed with the village council of the Village of Appleton, Swift County, Minnesota, a petition signed and executed by a majority of the owners of the platted land located and situated in Blocks One (1), Two (2) and Three (3) of the Appleton Heights Addition to the Village of Appleton, Swift County, Minnesota, which said lands abut upon the corporate boundaries of said village and do not exceed two hundred (200) acres in area, praying that the boundaries of the Village of Appleton, Swift County, Minnesota, be extended to include said Blocks One (1), Two (2) and Three (3) of the Appleton Heights Addition to the Village of Appleton, Swift County, Minnesota, together with all laid out streets and alleys adjacent thereto; and

Whereas, it appears that said petition in all things conforms to the statute in such cases made and provided,

Now, Therefore, the village council of the Village of Appleton, Swift County, Minnesota, do ordain as follows:

1. That the corporate boundaries and limits of the Village of Appleton, Swift County, Minnesota, be extended to include within the corporate limits of said Village of Appleton, Swift County, Minnesota, Blocks One (1), Two (2) and Three (3) of the Appleton Heights Addition to the Village of Appleton, Swift County, Minnesota, together with all laid out streets and alleys adjacent thereto.

2. This ordinance shall take effect and be in force from and after its publication and filing of the proof thereof and the filing of a certified copy thereof with the secretary of state of the state of Minnesota.

to local news of interest to the community it purports to serve; that during all said

time it has not wholly duplicated any other publication, and has not been entirely

made up of patents, plate matter and advertisements; has been circulated in and

near its said place of publication to the extent of at least two hundred and forty (240)

copies regularly delivered to paying subscribers and has entry as second class matter

in its local postoffice; and that there has been on file in the office of the County

Auditor of Swift County, Minnesota, the affidavit of a person having knowledge of

the facts, showing the name and location of said newspaper and the existence of the

conditions constituting its qualifications as a legal newspaper.

That the Notice hereto attached was cut from the columns of said newspaper, and was printed and published therein in the English language, once each week, for one successive weeks; that it was first so published on Friday, the 20th day of June, 1941; and thereafter on -- of each week to and including the -- day of --, 19 --; and that the following is a printed copy of the lower case alphabet from A to Z, both inclusive, and is hereby acknowledged as being the size and kind of type used in the composition and publication of said notice, to-wit:


