

On February 14, 1933 this deponent was duly appointed by Mike Holm, Secretary of State of the State of Minnesota, pursuant to Chapter 417, Laws of 1921 as supervisor of census, and V.F. Wilson, Andrew Johnson, Chas Chastor, Andrew Saari, Philip Fox, Frank Skerjanc, John Pakka, Byron Anderson, Robt Richard, Jack Teller, and George Hanson, all of St. Louis County, Minnesota, were duly appointed by said Secretary of State, pursuant to said act, as enumerators of the census, and this deponent and the eleven above mentioned enumerators were directed by the Secretary of State aforesaid to take a census of the residents of Independent School District No. 21, St. Louis County, Minnesota.

That thereafter this deponent and said enumerators agreed in writing and under oath to perform their duties in connection with said census faithfully and impartially and under the direction of said secretary of state as more fully appears from the affidavits hereto attached and made a part hereof.

That between the dates of Feb 19th and Feb 26th, 1933, all of the inhabitants of said school district were personally interviewed by one of the eleven enumerators above mentioned, working under deponent's supervision; that a separate card was prepared for each of the residents of said district, containing the name of such resident, and also containing other data, required by the Secretary of State; that these cards were prepared by said enumerators under the direction of this deponent and said cards have been duly filed with said Secretary of State; that the facts stated on said cards are true and reference is hereby made thereto for that purpose.

That as a result of said census, it appears that there were on Feb 25th 1933, Three Thousand Seven Hundred and Nine (3709) residents of said school district.

That after the enumeration of the inhabitants of said district, each of the eleven above mentioned enumerators and this deponent executed an affidavit to the effect that the facts stated in said cards were true. Said affidavits are hereto attached and made a part hereof.

Further, affiant sayeth not, save that this affidavit is made for the Secretary of State of the State of Minnesota to be filed in his office as a report of the results of the census of the inhabitants of said school district, made by this deponent under his direction.
