

RESOLUTION

The following resolution was offered by Commissioner Wiggins, seconded by Commissioner Olson, and unanimously adopted:

WHEREAS, pursuant to the provisions of Chapter 93, Laws of 1921, the electors of the Town of Progress, at a special meeting called for that purpose on July 14, 1921, unanimously voted by ballot to dissolve the town organization for the said Town of Progress; and,

WHEREAS, the Town Board of Supervisors of said town, have adopted a resolution setting forth such facts and asking for the dissolution of said town, and a copy of such resolution, duly certified by the town clerk, has been presented to the Board of County Commissioners of Carlton County, Minnesota; and,

WHEREAS, the county auditor has given ten days notice by one publication in The Pine Knot, the official newspaper, of the meeting of the county board at which such petition will be considered, and the county board have given due consideration thereto;

NOW, THEREFORE, Be it resolved by the Board of County Commissioners of Carlton County, Minnesota, that the town organization for the said Town of Progress is hereby dissolved, and that the territory formerly embraced within the said town, being congressional township forty-nine, (49), range nineteen, (19), hereafter shall be governed as unorganized territory of said Carlton County, Minnesota; and,

Be it further resolved, that for election purposes only the easterly eighteen (18) sections of said unorganized territory shall be attached to the Town of Birch Lake, and the westerly eighteen (18) sections thereof shall be attached to the Town of Red Clover.
