~~REPEALED~~ WHEREAS, Section 4 of the City Charter provides for the holding of general municipal elections in the City of St. Paul on the first Tuesday in May of even numbered years; and

WHEREAS, Numerous citizens of the city have been precluded from casting their votes on that day because of leasing dwellings on the first of May; and

WHEREAS, the Legislature of the State of Minnesota recently enacted Chapter 71, Laws of Minnesota for 1933, which provides that the governing body of a city of the first class is authorized by resolution adopted by a majority vote of the governing body to change the date of the general municipal election from the first Tuesday in May to the last Tuesday in April of even numbered years; therefore, be it

RESOLVED, That the general municipal election to be held in 1934 shall be held on the last Tuesday in April of said year and biennially thereafter; be it

FURTHER RESOLVED, that a copy of this resolution be forwarded for filing to the County Auditor of Ramsey County and the Secretary of State of the State of Minnesota, in accordance with the provisions of said Chapter 71, Laws of 1933.
