TO THE CITIES OF MINNEAPOLIS AND ST. PAUL, THE CITIZENS AND TAX PAYERS OF SAID CITIES, AND ALL OTHER INTERESTED PARTIES:

WHEREAS, the Minnesota State Board of Health, acting under and pursuant to Chapter 341, Laws of Minnesota 1933, did on the 5rd day of July 1933, find and determine that the discharge into the Mississippi River of sewage and industrial wastes from the area comprised of the cities of Minneapolis and St. Paul, in the State of Minnesota, does and is likely to endanger the public health, and does and is likely to cause a public nuisance, and that the removal and abatement thereof will be a benefit to such area; and

WHEREAS, the said Board of Health having so found, did by written order on the same day declare the area comprised of the said cities of Minneapolis and St. Paul to be and constitute a single senitary district in accordance with the provisions of said Chapter 341, Laws of Minnesota 1933,

NOW, THEREFORE, You and each of you are hereby notified that a public hearing will be conducted by the Minnesota State Board of Health at the Chamber of the House of Representatives in the State Capitol in the City of St. Paul on the 22nd day of August 1933, at 9 o'clock A. M. on the action of the said Board creating said sanitary district. At such hearing said cities of Minneapolis and St. Paul may appear and offer testimony and arguments, either for or against the creation of said sanitary district. Likewise any tax payer or citizen of either of said cities may appear and be heard in the metter. Dated this Erd day of July 1955.

#### MINNESOTA DEPARTMENT OF HEALTH

In the Matter of the Creation of a Sanitary District, Embracing the Cities of Minneapolis and St. Paul, Under and Pursuant to Chapter 341, Laws of Minnesota for 1933.

The State Board of Health of the State of Minnesota, acting under and pursuant to the terms and provisions of Chapter 341, Laws of Minnesota for 1933, at duly and regularly called meetings held in Millard Hall at the University of Minnesota in the City of Minneapolis on the 27th day of June 1933, and on the 3rd day of July 1933;

Having heretofore investigated and caused to be investigated each and every area in the said State of Minnesota, comprised of two or more contiguous cities of the first class, which directly or indirectly discharge sewage and/or industrial wastes into a common natural water course, which said cities do or may so discharge such sewage and/or industrial wastes into such water course as to endanger public health and/or to create a nuisance;

Having ascertained that the area comprised of the two cities of Minneapolis and St. Paul, and that each of said cities does discharge sewage and industrial wastes into the Mississippi River, a common natural water course;

Having inspected and caused to be inspected said area along and adjacent to said river where it enters the City of Minneapolis at its northerly limits and continuing through said Cities of Minneapolis and St. Paul; having viewed the sections of the river from the Minneapolis barge terminal, below the Washington Avenue bridge, in the City of Minneapolis, through the Twin City Lock and Dam, as far as the Hastings Dam, located above the City of Hastings; and having observed the actual polluted condition of the river and the discharge of the sewage and industrial wastes into the said river from the sewer outlets of Minneapolis, St. Paul and South St. Paul;

Having duly considered all the evidence which has been laid before and submitted to the said board relative to the aforesaid matters, and being fully advised in the premises, does hereby find the following facts and conditions:

#### MINNEAPOLIS and ST. PAUL - POPULATION

1. The Cities of Minneapolis and St. Paul in the State of Minnesota are each cities of the first class, each having a population of more than 50,000 persons. The population of Minneapolis, according to the last government census of 1930, was 464,356, and the population of St. Paul, according to the same census, was 271,606.

#### CONTIGUITY

2. The said Cities of Minneapolis and St. Paul have a common boundary and are contiguous to one another for a distance of about five and one-half miles, extending from the northern limits of the Ft. Snelling Military Reservation, along the proximate center line of the Mississippi River in a generally northerly direction to a point about midway between the Lake Street-Marshall Avenue bridge and the Chicago, Milwaukee, St. Paul and Pacific Railroad bridge, thence due north to the northern limits of St. Paul.

#### SEWER SYSTEMS and SEWAGE FLOW

3. Each of said cities maintains a system of sewers for the collection of sewage and industrial wastes which originate in each respective city and are created by its population. Such sewage and industrial wastes of said cities are being and for many years past, have been discharged into a common natural water course; to-wit, the Mississippi River. Based on measurements and estimates made by the Metropolitan Drainage Commission in the winter of 1927 and 1928, the average daily volume of such sower flow from Minneapolis into said

river, including private sewers, is approximately 63,000,000 gallons, and of the City of St. Paul approximately 38,000,000 gallons. Recent measurements and estimates indicate said amounts have probably increased since 1928. Based on measurements made in 1927-1928, the total quantity of suspended matter (sludge) on a dry ton basis being discharged each year into the Mississippi River from the Twin Cities is approximately 25,000 tons. On a wet sludge basis, 95% moisture, the total from the two cities would amount to about 500,000 tons, or nearly 600,000 cubic yards per year. These quantities do not include large amounts of street washings discharged during wet weather, or the wastes from the flour mills and the plant of the Gas Light Company of Minneapolis. The total sewage discharge from Minneapolis and St. Paul probably contains about 10,000 tons of fecal matter annually.

#### RIVER FLOW

4. For the past ten years the average monthly volumes of flow of the Mississippi River at the St. Anthony Falls, Twin City Lock and Dam, and at the Robert Street bridge in St. Paul have been greatly reduced as compared with previous similar periods of record. Especially during the years 1926, and 1929 to 1932, both inclusive, very low comparative flows were experienced. Higher flows occured in 1927 and 1928, but during the months of January and February, and from July to December of the years 1929 to 1932, both inclusive, the highest average monthly flow at St. Anthony Falls was 4,467 cubic feet per second in July 1929, and the lowest average monthly flow was 964 cubic feet per second in the month of September 1932. For only one month in 1931 (June), and for two months in 1932 (April and May) did the average flow at the Twin City Lock and Dam exceed 5,000 cubic feet per second. New low records for average monthly discharges since 1892 were established in 1931 for the period from August to November, and again in 1932 from August to December. These low flows were due chiefly to the lower annual precipitation of rain and snow in those

years, and resulted in a lack of surplus water available for discharge from the reservoir system at the head waters of the Mississippi. As a result the War Department of the Federal Government in February 1931 adopted a policy of maintaining as far as possible minimum levels in the reservoir system. During the years 1931 and 1932 an average of less than 500 cubic feet of water per second was discharged into the river from the reservoir system in consequence of the regulation policy above referred to.

#### TWIN CITY LOCK AND DAM

5. About six miles below St. Anthony Falls is located the Twin City Lock and Dam erected by the Federal Government in 1914 in aid of navigation. This dam has created a pool of relatively quiet water about five miles in length extending up stream to the Washington Avenue bridge in the City of Minneapolis. This pool had in 1928 a storage capacity of about 340,000,000 cubic feet. With an average discharge of 5,000 cubic feet per second at St. Anthony Falls, the flow time of the river from the falls to the Twin City Lock and Dam has increased approximately from two and onehalf to twenty-five hours due to the erection of the dam.

All of the sewage from the public and private outlets of Minneapolis, except one (the Minnehaha trunk sewer) and the sewage from eleven of the sewer outlets of St. Paul (representing about 25% of the total sewage volume of St. Paul) discharges into the river above the Twin City Lock and Dam. The amount so discharged from both cities averaged in 1928, 65,000,000 gallons daily.

#### SLUDGE AND SILT ACCUMULATION

6. In this pool, above the dam, sedimentation of sewage solids and other suspended matter in the water takes place. Soundings made in 1928 indicate that about 3,000,000 cubic yards of sludge and silt

had accumulated in the pool, the greater part of which had been deposited since 1914. Since 1928 the amount of sludge and silt in the pool has greatly increased. Soundings made in March 1933 indicated that over 4,300,000 cubic yards of sludge and silt had been deposited in the pool, an increase of 43% since 1928. The average yearly increase since 1914 has been about 225,000 cubic yards.

#### UNSANITARY CONDITIONS

7. Unsanitary and nuisance conditions in the pool became apparent shortly after the dam was constructed in 1914. Since then the unsanitary conditions of the pool have greatly increased. Large areas of the water at times are covered with masses of floating sludge, scum, and sleek. Rising gas bubbles throughout the summer months have been observed practically every year for the past ten years. This indicates septic conditions in the river and at times there exists an entire absence of dissolved oxygen therein. In 1927 it was considered on good authority that only when the flow of the river during the summer season was less than 5,000 cubic feet per second, would septic conditions be found in the pool; but in the months of May and June 1933 with flows in excess of 10,000 cubic feet per second, active septic conditions were apparent, evidenced in those months by the frequent appearance on the surface of the water of masses of sludge, scum, and sleek, and by vigorous and continuous gas ebullition from large quantities of putrefying masses of sludge brought to the surface by the action of the gases generated therein.

#### THE MISSISSIPPI GORGE

8. The river from the Washington Avenue bridge in Minneapolis to the mouth of the Minnesota River flows through a gorge with high wooded banks on each side. These banks, extending as far as the Twin City Lock and Dam, are a part of the park systems of Minneapolis and St. Paul and are much resorted to in the spring, summer and fall months

for recreational purposes. Along the summits of these banks, park boulevards are maintained by the respective park boards of the two cities, and facing these boulevards and in close proximity thereto many handsome and expensive dwellings have been erected on each side of the river. The foul condition of the river adjacent, due to the sewage discharges, has created a nuisance condition, and has rendered unsafe the use of the river for either boating, swimming, bathing, or fishing.

#### SEPTIC CONDITIONS AND PUBLIC NUISANCE

9. The septic conditions of this pool are due in part to the accumulated deposits of sludge during the winter months which have not been decomposed. As soon as the water warms up in the spring, decomposition sets in and foul objectional gases are generated, Odors emanating from the processes of decomposition and exposed scum and sleek, and from floating and stranded sludge have been persistent and prevalent during the summer months for many years past. There have been observed in the pool during the spring, summer, and fall months of the year for many years past, unsightly masses of floating sludge, fecal matter, dead animals, garbage, and debris, together with scum and sleek, all of which are most annoying to the sense of sight and smell. As a result, a public nuisance in the pool has existed for many years past and does now exist which is particularly obnoxious to those having their homes on or near the park boulevards above the river, to those who have occasion to cross any of the bridges spanning the river in Minneapolis and St. Paul, to those frequenting adjacent wooded banks for recreational purposes, and to those using the river for boating and navigation purposes.

#### RECENT AGGRAVATED SEPTIC CONDITIONS

10. The septic conditions of the river became intensified in the summer months of 1931 and 1932 due in large part to the low water of those years and the cumulative effect of sludge deposits in the pool.

Masses of floating sludge, scum, and sleek, fecal matter, garbage, and debris have been in recent years more apparent than ever in this pool. Vigorous gas ebullition from decomposing masses of sludge is frequently apparent especially during the warm months of the year. Nuisance conditions have been present with flow conditions representing 82% of the river discharge range as measured at St. Anthony Falls between the years 1900 and 1933.

#### HASTINGS DAM

11. Above the City of Hastings, and about eighteen miles below the City of St. Paul, the Federal Government in the fall of 1930 completed the construction of a new dam in aid of navigation, known as the Hastings Dam. This dam has created a second pool of relatively quiet water about thirty miles in length, extending up stream to the Twin City Lock and Dam. With an average discharge of 6,000 oubic feet per second at St. Paul, the flow time of the river from the Twin City Lock and Dam to the Hastings Dam, has been increased approximately from thirty hours to one hundred forty hours, due to the construction of the Hastings Dam. This pool receives the flow of the river in a highly polluted condition, and in addition into it is directly discharged the Minneapolis sewage from the Minnehaha trunk outlet, about three-fourths of the total sewage of St. Paul, and the sewage from the packing plants of South St. Paul and Newport, as well as the domestic sewage of South St. Paul and other smaller communities. The total average daily discharge of sewage directly from Minneapolis and St. Paul into this so-called Hastings pool was in 1928 about 36,000,000 gallons, and from the packing houses of South St. Paul and Newport, and the other nearby communities, about 10,000,000 gallons daily.

#### POLLUTED CONDITIONS IN HASTINGS POOL

12. A very polluted condition of the water has continuously existed in this section of the river for many years past, and the erection of the Hastings Dam has intensified this condition, especially

in the area extending from the Robert Street bridge in St. Paul to a distance three or four miles southwesterly to the Inver Grove bridge. The low point in the dissolved oxygen curve in the water of the river was found during the summer of 1932 to be about midway between St. Paul and the Hastings Dam in the stretch immediately below the Inver Grove bridge. Dissolved oxygen at this point was entirely or nearly exhausted for a period of four months during the summer and fall of 1932. This indicated the highest condition of pollution that has ever been found in this section of the river, covering an extended period of sampling and analysis since 1926. During the summer and fall months of 1932 and the spring months of 1933, numerous masses of floating sludge have been evident on frequent occasions in this area, at the St. Paul Bridge and Terminal bridge above South St. Paul, at the Inver Grove bridge, and above the Hastings Dam. Gas ebullition, due to the decomposition of organic sewage matter, has been frequently observed in this section of the river, particularly along the St. Paul water front, below the Inver Grove bridge, and above the Hastings Dam, since the water in the pool was raised to the fourteen foot stage in July 1931 by the operation of the dam. A distinct sewage odor is usually apparent at the Hastings Dam. In December 1932 when the pool was covered with ice this odor was particularly strong and offensive.

The presence of sleek and scum has been very noticeable along the water front in the business section of St. Paul during the summers of 1931 and 1932, and in the spring of 1933. Much of the discharge from the sewers in the form of garbage, paper, rags, and debris has drifted to the river banks, forming unsightly, ill-smelling accumulations. Much of this shore littoral was observed this spring below the Robert Street bridge in St. Paul. Sludge banks or flats formed by the deposit of sludge, often near the sewer outlets in the river, have been found to exist in several places both above and below the Twin City Lock and Dam. These often give rise to objectionable sewage odors. Foul sewage odors have been noticed in recent years in the vicinity of the Robert St. bridge, below the Inver Grove bridge and at the Hastings Dam

during the spring, summer, and fall months, These odors are due in part to the gases and vapors from the sewer discharges of the cities, and in part to the decomposition of sludge masses in the river. These odors are especially noticeable to persons obliged to work on or near the river, or who have occasion for any reason to be near it. An extremely polluted and nuisance condition exists in this secion of the river. While this is due in part to the discharge of industrial wastes from the packing houses of South St. Paul and Newport, the evidence establishes that the sewage and industrial wastes from the cities of Minneapolis and St. Paul largely contribute to the foul conditions of the river throughout the whole of this area.

#### PUBLIC HEALTH HAZARD

13. The river in its present polluted condition in the Twin City area, and as far south as Lake Pepin, constitutes a serious potential menace to the public health and would be much more dangerous were: it not for the precautions that have been taken by communities bordering thereon, to limit and prevent the use of the water and contact with it in its raw state.

Both Minneapolis and St. Paul now derive their water supply in whole or in part from intakes of the Mississippi River located above the point where the first Minneapolis sewer outlet discharges. The water so used is subjected to purification processes.

The influence and effect of sewage discharges from the Cities of Minneapolis, St. Paul, South St. Paul, Newport, and their industries, can be traced in the river as far as Lake Pepin, forty miles below St. Paul and possibly further. While there are no cities in Minnesota or Wisconsin below the Twin Cities which are now using river water as a source of public water supply, there was a time when some of these communities took their water supply from the river. Later they resorted to the use of wells. However, there is no assurance that these down-river communities will be able to depend upon wells for their domestic water indefinitely. It is possible that some, if not many of them, will be compelled or find it convenient

at sometime in the future to resort to the Mississippi River for an adequate water supply. The river water at the present time between the Twin Cities and Lake Pepin is so polluted that it would either be impossible to treat it sufficiently to make it safe for domestic use, or else the expense of purification would be so great as to be practically prohibitive.

#### PREVIOUS TYPHOID EXPERIENCE IN MINNEAPOLIS

14. The records of the State Health Department show that typhoid fever was unduly prevalent in Minneapolis throughout the two decades from 1891 to 1910. In no year did the number of deaths from this disease fall below 53. The highest in 1910 was 185. The average for the period was 95. Typhoid epidemics resulting in more than 100 deaths annually occurred in each of eight years between 1891 and 1910. It is generally considered that the fatality rate in typhoid cases ranges from 7% to 10% of actual cases of the disease. ### CONTAMINATION OF DOMESTIC WATER SUPPLY BY INFILTRATION

16. In 1928 an outbreak of diarrhoea occured in Hastings. This was traceable to a municipal well supplying domestic water located near the river which probably became contaminated through infiltration of raw river water.

#### BATHING IN THE AREA

17. Experience has shown that a serious menace to the public health exists from bathing in polluted waters. Numerous cases of typhoid, diarrhoea. dysentery, and inflammatory diseases of the skin, eye, ear, nose, and throat are and have been traceable to the polluted conditions of water, due to the presence of sewage and of the high bacterial pollution which accompanies it. Prior to 1925 a public bathing beach was maintained by the City of Minneapolis at Hall's Island, near the Plymouth Avenue bridge, and in St. Paul prior to 1919 a similar public beach was operated by the city on Harriet Island in the river, near the Wabasha bridge. The polluted condition of the re river due to the presence of large amounts of sewage compelled the abandonment of these beaches.

It is a matter of common knowledge that it is practically impossible to prevent the use of the river in the Twin City area for bathing in the summer season by those who are ignorant of the dangers inherent in the polluted waters. It is almost a daily occurrence during the summer months for parties of men and boys to bathe in the gross ly polluted area of the river below the St. Anthony Falls and Twin City Lock and Dam and in other places in Minneapolis, St. Paul, South St. Paul, and Newport.

#### RIVER BOATING

18. The use of the river for commercial navigation and boating for recreation in the Twin City area constitutes a hazard to health, for the reason that it is practically impossible for those so using the river to avoid coming in contact with the polluted water. Infections similar to those acquired by bathers result to those operating

boats on the river. The tow boats operated by the Inland Waterways Corporation are accustomed to carry and have frequent occasion to use antiseptic solutions and disinfectants for the treatment of skin diseases contracted by the crews which operate the tow boats and barges. These infections result from handling the tow lines and through other unavoidable contact with the water.

Boats operated on the river frequently use river water for boiler and washing purposes, and while an attempt is generally made to purify the same in some manner, a distinct hazard exists in such use of the river water, arising from the possibility of defective apparatus, careless handling, etc. A number of outbreaks of typhoid and dysentery have occurred in years past on various types of boats operating on the Mississippi River below the Twin Cities and as far south as the state line, which were traced to the use of raw river water for drinking or bathing.

The river adjacent to the St. Paul air port is being used to some extent as a landing place for hydroplanes. Such use of the river in this highly polluted water constitutes a health hazard similar to that attendant upon boating.

The University of Minnesota has declined to allow students to use the pool in the river above the Twin City Lock and Dam for rowing, on the advice of the State Board of Health, which stated in 1919 that the polluted condition of the water in this area made it unsafe for use in aquatic sports. This statement was reaffirmed in 1927.

#### HEALTH HAZARD AS AFFECTED BY RIVER DISCHARGE

19. While the relative river discharge affects the dilution and to some degree the concentration and distribution of pathogenic bacteria per unit of volume, nevertheless the effects of the river discharge are such that even under quite wide variations, a health hazard obtains in the section of the river from the northerly limits of Minneapolis into and possibly below Lake Pepin. With relatively

low discharges, the concentration of pathogenic bacteria is likely to be greater than under conditions of high discharge. On the other hand, when the river discharge is high the flow time in the river is relatively short and the point to which large numbers of pathogenic organisms are likely to be carried, would be moved farther downstream.

A health hazard exists in the river with both high and low discharges. Cases of typhoid and diarrhoea have been reported in the past when the monthly discharge at St. Paul was as low as 2500 cubic feet per second and as high as 31,200 cubic feet per second. A health hazard is known to exist with discharges representing 89% of the discharge range of the river.

## OTHER HEALTH MENACES OF THE RIVER FROM THE TWIN CITY AREA SOUTHWARD

20. There are certain other health menaces connected with the gross pollution of the river in the Twin City area. Among these are the following:

Fishing: While fish life is restricted or driven off in the highly polluted areas near the Twin Cities, some fishing is done between the outlet of the Minnesota River and the high bridge in St. Paul. The handling of fish taken in these waters is attended with danger of infection to fisherman, and there is also a danger in consuming and eating such fish where it is not thoroughly cooked.

<u>Milk Supplies:</u> Dairy herds are pastured in the area along the highly polluted sections of the river in the Twin City area, and are permitted to wade in and drink the river water. The cattle frequently carry away infected material on their udders and flanks and this is likely to infect the milk. Another hazard in this area arises from the custom of dairymen to use raw river water for rinsing milk vessels and hand washing. One recent outbreak of typhoid fever in Minnesota is traceable to this practice.

<u>Ice:</u> Ice is sometimes cut in polluted sections of the river from the Twin City area southward. While no direct evidence has been secured that such practice has resulted in the spread of water-borne disease, there is a grave possible source of the spread of typhois and gastro-intestinal diseases from the use of infected ice.

Flies: Flies which are attracted to the deposits of scum and sludge in the river and along the banks of the polluted sections are likely to convey infection to milk and other foods exposed in the vicinity of the river.

#### RECREATIONAL USES OF RIVER BANKS

21. The river banks are a part of the public park systems in the Twin Cities and invite people, both adults and children, to resort thereto for recreation, picnics, etc. Many in ignorance of the dangers involved are tempted to use the river water for cooking and washing dishes, for bathing, and possibly for drinking. So long as the river in the Twin City area exists in its polluted condition, such use of the water constitutes a distinct health hazard.

#### FINDINGS MADE IN 1928

22. The State Board of Health in 1928 made certain findings and determinations with respect to the existence of public health hazards and conditions of public nuisance in the Mississippi River, extending from the Twin City area south to Lake Pepin. On further evidence presented, based upon the study of river conditions continued up to the present time, the State Board of Health now reaffirms these findings and conclusions, as follows:

(a) A condition of gross pollution exists in the pool above the Twin City Lock and Dam and extends from this pool to the mouth of the St. Croix River.

(b) A hazard exists from a public health standpoint, especially

in the grossly polluted areas to persons bathing, boating or in any way coming in intimate contact with the river water or deposits of sludge.

(c) A condition of public nuisance exists except during periods of relatively high water, in the section of the river from the head of the pool of the Twin City Lock and Dam in Minneapolis to the influx of the St. Croix River at Prescott.

#### RIVER ZONES

23. The State Board of Health now finds that while the construction and operation of the Hastings Dam has somewhat altered the situation, nevertheless the river may be divided roughly into four zones, as follows:

(a) A zone of heavy pollution extending from Minneapolis to the mouth of the St. Croix River at Prescott. The river in this zone, beginning at Minneapolis, is unfit for use as a source of water supply, for bathing, or for boating, and is a potential danger from a health standpoint to persons and live stock coming in contact with the water.

(b) A zone of partial recovery extending from Prescott to the head of Lake Pepin. Conditions in this zone after the influx of the St. Croix River show an improvement as a result of the addition of diluting water from this river and the natural processes of stream purification. Even in this zone, the river is unfit for use as a source of water supply, or for bathing and is dangerous to the health of those coming in contact with the water. Nuisances are less frequent

(c) A zone of more complete recovery through Lake Pepin. Under certain conditions polluted material is carried into the lake in sufficient quantities to endanger the health of bathers and others coming into contact with the water. Somewhere in the lake the coli-aerogenec content is reduced to a point where it meets the standards for permis-

sible loading of water purification plants.

(d) A zone of intermittent pollution and recovery below Lake Pepin. The water below Lake Pepin appears to have practically recovered from the effects of the pollution introduced above the lake.

#### CONCLUSIONS AND ORDER

24. The State Board of Health by reason of the foregoing facts and conditions does therefore find and determine:

A. That the discharge of sewage and industrial wastes in the Mississippi River from the area comprised of the Cities of Minneapolis and St. Paul,

- 1. Does now endanger the public health.
- 2. Is likely in the future to increase the dangers to the public health.
- 3. Does now cause a public nuisance.
- 4. Is likely in the future to cause and create a further and greater public nuisance.

B. That the creation of a sanitary district under the terms and provisions of Chapter 341 Laws of Minnesota for 1933, comprised of the area of the Citics of Minneapolis and St. Paul, designed to accomplish the removal and abatement of the sewage and industrial wastes now being discharged by the said cities and its inhabitants into the Mississippi River is proper and required in the interest of the public health.

C. That the removal and abatement of such sewage and industrial wastes will conserve the public health, comfort, and convenience of the communities of Minneapolis and St. Paul; will make said communities and each of them more desirable as places of residence, for transacting business, and for engaging in useful occupations and recreations on the part of the citizens, inhabitants, and property owners of such cities; will enhance the value of the property in said communities, and will be of benefit to such area and to the property of the citizens and tax payers of the citles included ...... therein.

WHEREFORE, the State Board of Health acting under and pursuant to the authority conferred upon and vested in said board in accordance with the terms and provisions of Chapter 341, Laws of Minnesota for 1933,

DOES HEREBY DECLARE AND ORDER:

That the area comprised of the two cities of the first class; namely, the Cities of Minneapolis and St. Paul in the said State of Minnesota, to be and constitute a single sanitary district, with all the rights, powers, duties, and obligations vested in and imposed upon such sanitary district under and pursuant to the provisions of said Chapter 341, Laws of Minnesota for 1933.

That the said City of Minneapolis is specifically included within said sanitary district for the reason that the sewage and industrial wastes discharged from said city into the Mississippi River cause a great and increasing burden upon the capacity of the river to absorb and oxidize said burden of pollution, taking into account the volume of the flow of said river and the rights of existing communities on said river below said city, to receive the flow of said stream in a state and condition reasonably free from pollution; and for the reasons that the discharge of sewage and industrial wastes from said City of Minneapolis tends to and does endanger the public health and tends to and does create a public nuisance, and the removal and abatement thereof will be a benefit to said city and to the property of the citizens and tax payers therein.

That the said City of St. Paul is specifically included within said sanitary district for the reasons that the sewage and industrial wastes discharged from said City into the Mississippi River: cause a great and increasing burden upon the capacity of the

river to absorb and oxidize said burden of pollution, taking into account the volume of the flow of said river and the rights of existing communities on said river below said city, to receive the flow of said stream in a state and condition reasonably free from pollution; and for the reasons that the discharge of sewage and industrial wastes from said City of St. Paul tends to and does endanger the public health and tends to and does create a public nuisance, and the removal and abatement thereof will be a benefit to said city and to the property of the citizens and tax payers therein.

Some time ago I advised you that I desired to withdraw as your representative on the Minneapolis-Saint Paul Sanitary District Board of Trustees; but I did not at that time tender a formal resignation because of the fact that you indicated that it would still be of some assistance to you for me to remain upon the Board for a short time.

The City Council has before it many serious and important problems which require practically all, if not all of our time, and I feel that I should be relieved of this duty. I was very glad to assume it to assist you at the time you appointed me, but as your health has been restored, I feel that you will be able to devote more time to the duties than I would be. Having followed the proceedings by discussion with me of the various problems involved, you are in a position to give as good, or better service, than I might. I therefore hereby tender my resignation, effective Monday, the 25th day of March, 1935.

If I can be of any assistance to you in the way of explanation of what has been done or is being done, do not hesitate to call upon me.

There is one matter that is being discussed, to which I believe I should call your attention. The budget estimates include one or two substantial items covering "additional capacity required for territory adjoining villages." This is already being considered by the Gity Council upon motion of Alderman Burgum. I believe that we should make such arrangement or longterm contracts with adjoining villages, so that the city will not be in the position of expending these substantial sums of money for additional capacity without being able to recover compensation therefor from such villages. This matter has been called to the attention of the legal department of the city, and I am informed that an investigation is being made.

Please accept my congratulations upon your return to health and be assured of my co-operation in any way that you desire it in this matter.
