to-wit:--

Beginning at a stone monument on the East-West
quarter line of Section Nine, Township One Hundred
Three North, Range Thirty, West of the Fifth P. M.,
Martin County, Minnesota, Three Hundred Thirty-eight

Section Nine; running thence East on quarter line
