

ORDINANCE NO. 41

For the annexing of  
 a certain portion of the Village of Walker on  
 the 11th day of September, A.D. 1908.

Whereas Charles Kinkade has presented to  
 the Village Council of the Village of Walker  
 a certain portion of the Village of Walker  
 to the Honorable Village Council of the  
 Village of Walker.

It is the duty of the Village Council of the  
 Village of Walker, Cass County,  
 Minnesota, to determine whether or not I am  
 the owner of the following described unplat-  
 ted land situated in the Village of Walker  
 to-wit: all that portion of the south east quar-  
 ter of the south east quarter (sec 4) of  
 township one hundred and thirty  
 one north of range thirty  
 one east of Cass County, Minnesota, lying  
 south of the original townsite of Walker and  
 east of a line which is a straight continuation  
 of a southerly line of the western line of  
 the townsite of Walker, accord-  
 ing to the plat recorded in the office of the  
 Register of Deeds of Cass County, Minnesota; and I  
 especially petition that said land be annexed  
 to and included within the  
 corporate limits of said Village of Walker.

 from and after the passage and publication and  
 the filing of a certain copy thereof in the of-  
 fice of the Secretary of State of Minnesota.
