

RESOLUTION DECLARING THE RELINQUISHER OF THE SPECIAL VILLAGE

CHARTER AND REINCORPORATING UNDER CHAPTER 9 OF THE

REVISED LAW OF 1905.

Whereas the Village of Rush City was organized and now exists pursuant to the provisions of Chapter 24 of the special law of 1873, being "An Act to Amend An Act Entitled An Act to Incorporate the Village of Rush City and Provide for an Election thereon, approved March 8th, 1873," as amended;

And whereas, the Village Council has by resolution dated the 13<sup>rd</sup> day of March, 1908, ordered that a special election hereby of the electors of the Village of Rush City be held at the Village Hall in the said Village of Rush City, Chisago County, Minnesota, on Tuesday, the 7th day of April, A. D. 1908, between the hours of 9 o'clock A. M. and 5 o'clock P. M. to vote upon the question of relinquishing the old special charter and to be reincorporated and to be governed by Chapter 9 of the Revised Law of 1905 as amended;

And whereas, at the special election so held by the electors of the Village of Rush City on the 7th day of April, A. D. 1908, there were cast 176 votes, of which there were cast for reincorporation 113 votes, and against reincorporation 63 votes, being a majority of 50 votes in favor of reincorporation.

Now therefore, it is hereby resolved that the Village of Rush City hereby does relinquish the special charter under which it now exists, being Chapter 24 of the special Law of 1873, being "An Act to Amend An Act Entitled An Act to Incorporate the Village of Rush City and Provide for an Election thereon, approved March 8th 1873," as amended; and that it does hereby reincorporate and reorganize as a village pursuant to the provisions of Section 638 and 639 of the Revised Law of 1905, as amended, and that hereafter

the said Village of Rush City shall be governed by the general village laws of the state as set forth in Chapter 9 of the Revised Laws of 1905, as amended.

Be it further resolved that all ordinances of the said Village of Rush City now existing and not in conflict with the provisions of the new Charter shall be and hereafter remain in effect until modified, amended or repealed.
