

RESOLUTION DECLARING THE RELINQUISHMENT OF THE SPECIAL VILLAGE

CHARTER AND REINCORPORATION UNDER CHAPTER 9 OF THE

REVISED LAWS OF 1905.

Whereas the Village of Rush City was organized and now exists pursuant to the provisions of Chapter 24 of the special laws of 1878, being "An Act to Amend An Act Entitled An Act to Incorporate the Village of Rush City and Provide for an Election therein, approved March 8th, 1878," as amended;

And whereas, the Village council did by resolution dated the 13th day of March, 1908, order that a special election ~~between~~ of the electors of the Village of Rush City be held at the Village Hall in the said Village of Rush City, Chicago County, Minnesota, on Tuesday, the 7th day of April, A. D. 1908, between the hours of 9 o'clock A. M. and 5 o'clock P. M. to vote upon the question of relinquishing the old special charter and to be reincorporated and to be governed by Chapter 9 of the Revised Laws of 1905 as amended;

And whereas, at the special election so held by the electors of the Village of Rush City on the 7th day of April, A. D. 1908, there were cast 178 votes, of which there were cast for reincorporation 113 votes, and against reincorporation 65 votes, being a majority of 50 votes in favor of reincorporation.

Now therefore, it is hereby resolved that the Village of Rush City hereby does relinquish the special charter under which it now exists, being Chapter 24 of the special laws of 1878, being "An Act to Amend An Act Entitled An Act to Incorporate the Village of Rush City and Provide for an Election therein, approved March 8th 1878", as amended; and that it does hereby reincorporate and reorganize as a village pursuant to the provisions of Section 628 and 629 of the Revised Laws of 1905, as amended, and that hereafter

the said Village of Rush City shall be governed by the general village laws of the state as set forth in Chapter 9 of the Revised Laws of 1905, as amended.

Be it further resolved that all ordinances of the said Village of Rush City now existing and not in conflict with the provisions of the new Charter shall be and hereafter remain in effect until modified, amended or repealed.
