

PROPOSED AMENDMENT

TO THE CHARTER OF THE CITY OF MOORHEAD, MINNESOTA, AUTHORIZING THE PAVING OF CERTAIN STREETS, PROVIDING FUNDS, AND THE ISSUE OF \$10,000 BONDS THEREFOR.

To the Hon. Edwin J. Wheeler, mayor, and the Council of the City of Moorhead, Minnesota:

We, the undersigned, appointed on the 13th day of November, A. D. 1908, by the Honorable, the district court of Minnesota, in and for the County of Clay, as a Charter Commission for the said City, do hereby respectfully submit the following amendment to the Charter adopted by the City of Moorhead on the 22nd day of May, A. D. 1900, to-wit:

To amend Chapter XV of the Charter of the City of Moorhead by adding thereto:

Sec. 231. For the purpose of enabling the City of Moorhead to construct a permanent pavement on the following described streets in said City, viz: Front street from Ninth street to Third street, Eighth street from Northern Pacific track to Great Northern track; Sixth street from Northern Pacific main track to a point one hundred fifty (150) feet north of the north line of Front street; Fourth street from First avenue north to First avenue south, and First avenue south from Fourth street to the south bridge, the City Council of said City, by a two-thirds vote thereof, at any meeting, is hereby authorized to call for bids and enter into the necessary contracts for the construction of such pavement upon the aforesaid streets, all provisions of the Charter to the contrary notwithstanding;

And, it is further provided that for the years 1908 and 1909, the sum of Five Thousand (\$5,000) dollars required by sub-section 1, of section 94, of chapter V of the Charter to be retained in the Sinking fund to provide for the payment on the bonded indebtedness of the City shall during each of said years be placed in the permanent improvement fund and shall be applied solely to the payment of the City's proportion of the cost of the heretofore mentioned pavement.

And, provided further, that the City Council may issue without further authority, bonds to the amount of Ten Thousand (10,000) dollars as authorized by sub-section two (2) of Section 98 of Chapter V of the Charter, which may be transferred from the permanent improvement revolving fund to the permanent improvement fund, to be used solely for the purpose of paying the City's proportion of the cost of said pavement;

And, provided further, that all obligations on account of said pavement before made payable on or after the 1st day of January, 1909, shall be paid out of the permanent improvement revolving fund.

And, provided further, that the publication and adoption of the foregoing amendment shall be deemed a sufficient notice to all property owners and persons to be affected by the aforesaid pavement.

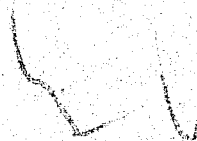
