Introduced by Commissioner Hensrud:

BE IT RESOLVED, By the Board of County Commissioners of Freeborn County, Minnesota, that the form of the petition for incorporation of the Village of Hollandale this day presented to said Board for consideration, and which petition is now on file in the office of the County Auditor of Freeborn County, Minnesota, and bears date January 9, 1934, be approved.

BE IT FURTHER RESOLVED, That a notice be given of an election to be held upon said petition, which election shall be held in the Village of Hollandale, Freeborn County, Minnesota, on the 10th day of February, A.D. 1934, from nine o'clock A.M. to twelve o'clock noon, in the basement of the school building in said Village of Hollandale, and further that copies of said notice, together with copies of said petition be posted in three public posting places within the boundary of said proposed incorporated village, one at each of the following places:

1. The bulletin board in the office of the Hollandale Marketing Association;
2. The bulletin board in the bank building of the Produce State Bank of Hollandale;
3. The bulletin board in the Hollandale postoffice;

and further, that H. C. Anderson, Rev. A. A. Schermer and Mfs. J. A. Roth, who residents and voters residing in said territory, be appointed as inspectors, who shall act as judges of said election, and conduct the same in the manner provided by law.

NOTICE OF ELECTION ON PETITION FOR  
INCORPORATION OF VILLAGE OF HOLLANDALE.

NOTICE IS HEREBY GIVEN, That an election will be held upon the petition for incorporation of the Village of Hollandale, which petition bears date the 9th day of January, A. D. 1934, a copy of which is hereto attached, marked Exhibit "A" and made a part of this notice. Said election will take place in the basement of the school building in the Village of Hollandale, in Freeborn County, Minnesota, located upon the premises described in the attached petition, on the 10th day of February, A. D. 1934, from 9:00 A. M. to 12:00 noon.

It is ordered that a copy of this notice, with a copy of the petition attached thereto, shall be posted in three public posting places within the boundary of the proposed incorporated village, and said three public posting places are hereby designated as follows:

1. The bulletin board in the office of the Hollandale Marketing Association;
2. The bulletin board in the bank building of the Produce State Bank of Hollandale;
3. The bulletin board in the Hollandale postoffice.

It is further ordered that H. C. Anderson, Rev. A. A. Schermer, and Mrs. J. A. Roth, who are residents and voters residing on said territory, are hereby appointed inspectors, who shall act as Judges of said election and conduct the same insofar as practicable in accordance with the laws regulating the election of town officers.

Only voters residing within said territory shall be entitled to vote. The ballot will bear the words:

"For Incorporation, Yes \_\_\_\_\_ No \_\_\_\_\_"

with a square after each of the last two words, in one of which the voter shall make a cross to express his choice.

Report of said election shall be made promptly by said inspectors to the County Auditor of Freeborn County, Minnesota.

PETITION FOR INCORPORATION  
OF  
VILLAGE OF HOLLANDALE

TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS OF FREEBORN COUNTY,  
MINNESOTA:

The undersigned, being twenty-five or more of the voters residing within the territory hereinafter described, hereby respectfully petition the Board of County Commissioners of Freeborn County, Minnesota, being the county and state in which said lands are located, to call an election for the determination of the incorporation of the said lands as a village to be known as the Village of Hollandale, in the manner provided by law.

The lands and premises herein petitioned to be incorporated as said Village of Hollandale, are located in the Townships of Riceland and Geneva, in the County of Freeborn and State of Minnesota, and have heretofore been platted into lots and blocks in accordance with plats which have been duly and legally certified according to the laws of the State of Minnesota, and filed in the office of the Register of Deeds of Freeborn County, Minnesota, all of which lots and blocks are contiguous to and are contained and lie within the following described premises, to-wit:

All that part of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Thirty-five (35), township One Hundred Four (104), Range Twenty (20), lying south of Judicial Ditch #4, as it passes diagonally northwesterly and southeasterly across said quarter section, and as legally established in accordance with the order of the District Court of the Tenth Judicial District, Freeborn County, Minnesota;

Also the Northwest quarter (NW $\frac{1}{4}$ ) of Section Two (2), Township One Hundred Three (103), Range Twenty (20);

All of said lands and premises have been platted in accordance with the plat designated as the Village of Hollandale, and of the plats of the accititions to said village, which plats are on file in the office of the Register of Deeds in and for said county and state. Said foregoing described premises contain approximately two hundred fifty-five (255) acres.

That a careful census of the resident population residing within and upon said lands has been taken and ascertained to be 166 as of the date of this petition.

That three public posting places within the boundaries of the above described premises which are likely to attract the most attention of passersby are as follows:

1. The bulletin board in the Hollandale Marketing Association building;
2. The bulletin board in the bank building of the Produce State Bank of Hollandale;
3. The bulletin board in the lobby of the Hollandale postoffice.

There is no legally qualified newspaper published within said territorial limits.

WHEREFORE, Your petitioners pray:

- I. That your Honorable Board post a copy of this petition, together with a notice attached fixing a time and place for holding an election for the determination of such proposed incorporation, to be posted in the three public posting places described and referred to in this petition, or in three other public places within the boundaries of the lands above described;
- II. That said time for holding said election be fixed at not less than twenty (20) nor more than thirty (30) days after the posting of said notices and copies of this petition, and that the place for holding said election be fixed within the limits of the proposed village;

III. That said Board also appoint three inspectors who are residents of said territory to act as Judges of said election, and conduct the same as far as practicable in accordance with the laws regulating the election of town officers;

IV. That such other steps be had and taken as are necessary to fully comply with all the laws of the state for the incorporation of such village.
