We, the undersigned gualified electors and residents of, in and upon the following described lands and territory lying and being in the County of Otter Tail, State of Minnesota, and described as follows, to-wit:

That part of the Southeast quarter of the Northwest quarter, the Southwest quarter of the Northwest quarter, and the North half of the Southwest quarter of Section twelve, township one hundred thirty-two, range thirty-nine, platted into lots and blocks and designated as Vining, which plat was filed in the office of the Register of Deeds in and for the County of Otter Tail and State of Minnesota on the 24th day of November, A.D. 1882, at 2 o'clock P.M.
