The name of the candidate shall be printed upon the primary ballot when he shall have filed for any elective office, in the manner hereinafter set forth.

Affidavit of candidacy.—Sec. 12. Not later than twenty-one days before the primary election, nor before January 2nd of such election year, any person eligible and desirous of having his name placed on said primary ballot shall signify such desire by filing an affidavit of candidacy with the City Clerk.

Requirements of affidavit.—Sec. 13

shall signify such desire by filing an affidavit of candidacy with the City Clerk.

Bequirements of affidavit.—Sec. 13 Such affidavit shall state the full name of the candidate, his residence, that he is a qualified voter in the City of Saint Paul, and the title of the office for which he desires to become a candidate.

Statement of principles—Sec. 14 Said affidavit may contain a statement not to exceed fifty words settling forth such candidate's principles or policies for the office for which he is a candidate, but shall in no way disclose his political party affiliations.

Filing fee—Sec. 15 Upon the payment by said candidate to the City Clerk of the City of Saint Paul of the sum of Ten Dollars (\$10.00), the City Clerk shall place the name of said candidate upon the primary election ballot.

Withdrawal of candidacy.—Sec. 16 Any candidates of filed may not later than twenty-one days before said primary election, withdraw his name as a candidate at such election by filing with the City Clerk an affidavit setting forth the fact of such withdrawal and requesting said City Clerk to withdraw said candidate's name from such primary ballot

Preservation of affidavits.—Sec. 17. The City Clerk shall preserve for a period of two years all affidavits of candidacy and withdrawal.
