GOVERNOR'S ORDER NUMBER 10, EXTENDING PROTECTION TO DEER
IN CERTAIN COUNTIES AND PORTIONS OF COUNTIES IN THE STATE
OF MINNESOTA, DURING THE YEAR 1934.

* * * *

Whereas, it has been represented to the
Director of Game and Fish that deer are in danger of undue
depletion in certain Counties in the State of Minnesota, and

Whereas, the Director of Game and Fish has
investigated and has presented me with the results of his
investigation and has recommended that protection be given
deer in all of the counties and portions of counties in the
State of Minnesota, during the year 1934, except such counties
and portions of counties as are listed below, to prevent their
undue depletion:

Gook, Lake, St. Louis, Carlton, Pine, Aitkin,
Crow Wing, Cass, Itasca, Koochiching, Hubbard,
Clearwater, Beltrami, Lake of the Woods, Roseau;
all of that portion of Kittson and Marshall
Counties lying east of the Mpls. St. Paul &
Sault Ste. Marie Railway track running from the
northern boundary of Kittson County to the
southern boundary of Marshall County; and all
of that portion of Becker County lying east
of the Mpls. St. Paul and Sault Ste. Marie Rail-
way track running from the northern to the
southern boundary of said County.

Itasca County open to the taking of antlered male deer only.
Does and fawns protected in this County.

Now, therefore, I, Floyd B. Olson, Governor of
the State of Minnesota, by virtue of and pursuant to authority
vested in me by Section 5640, G. S. 1923, do hereby order that
no deer shall be taken in any counties or portions of counties
during the season of 1934, except those counties and portions of
counties listed herein.

This order shall remain in force until the close
of the 1935 regular session of the Legislature of the State of
Minnesota, unless sooner revoked or modified.
