CERTIFICATE OF CONSENT BY THE STATE OF MINNESOTA
TO THE ACQUISITION OF LANDS BY THE UNITED STATES.

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, the Secretary of Agriculture of the United States, pursuant to the provisions of General Statutes of Minnesota of 1923, sections 4 and 6, and to the acts of Congress hereinafter set forth, has made application for the consent of the State of Minnesota to the acquisition by the United States of the lands hereinafter described, which lands have been acquired by the United States under the authority of the Act of Congress of March 1, 1911 (36 Stat. 961), as amended by section 6 of the Act of Congress of June 7, 1927, (43 Stat. 653), for certain national purposes therein specified, to-wit, for a national forest;

AND WHEREAS, proof has been made that the title to said lands has duly vested in the United States;

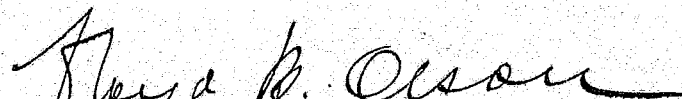

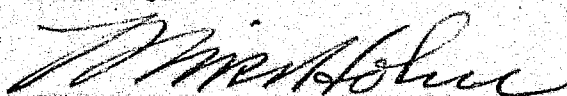
