

VILLAGE ORDINANCE NO. 26

* * * * *

An Ordinance Extending the Present Boundaries of the Village of Biwabik and Annexing to said Village Certain Land Commonly known as the Wm. Smith Property.

* * * * *

The Village Council of the Village of Biwabik, in Saint Louis County, Minnesota, do ordain as follows:

SECTION I. Annexation.--- Pursuant to and in conformity with Section 707 of the Revised Laws of Minnesota, 1906, the present corporate limits and village boundaries of the Village of Biwabik, St. Louis County, Minnesota, are hereby extended so as to include all that piece and parcel of land outlined, bounded and described in Section 2 hereof and the same is hereby annexed to, declared to be an addition to, and a part of the Village of Biwabik as effectually as if the same had been originally a part thereof.

SECTION II. Description of Property.--- The land hereby annexed being adjacent to and abutting upon the present corporate limits of the Village of Biwabik is described as follows; to-wit;

That portion of the Northwest quarter (1/4) of the Northwest quarter (1/4) of Section 11, Township 58, Range 16, North of the 4th Principal Meridian, Saint Louis County, Minnesota, more specifically described, outlined and bounded as follows, to-wit; a strip of land on the extension of Canton Avenue commencing at the point at the Southeast corner of Block numbered 55, of the Village of Biwabik, running in a Southerly direction to make a direct continuation of the West line of Canton Avenue to a point seventy-five (75) feet South of the Southeast corner of said Block numbered 55, thence West at right angles to said last named line, to a point of intersection with the Northeasterly line of the right-of-way of the Duluth & Iron Range Railway, thence in a Northwesterly direction along said Northeast line of said right-of-way to the point where

said Northeast line of said right-of-way intersects with the South line of said Block numbered 55, thence in an Easterly direction parallel to the Southerly line of said Block numbered 55 to the point of commencement.

SECTION III. Outlot.--- The land described, outlined and bounded in Section 2, of this ordinance is hereby designated and shall hereafter be known as "Outlot NO. 1." of the Village of Biwabik.

SECTION IV. Certified Copy to be Filed.--- The Village Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the Secretary of State.

SECTION V. When to take Effect.--- This ordinance shall take effect and be in force from and after its passage and publication and the filing of a certified copy hereof with the Secretary of State.

Section 3. Outlet.—The land described, outlined and bounded in Section 2, of this ordinance is hereby designated and shall hereafter be known as "Outlet No. 1" of the Village of Biwabik.

Section 4. Certified Copy to be Filed.—The Village Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the Secretary of State.

Section 5. When to Take Effect.—This ordinance shall take effect and be in force from and after its passage and publication and the filing of a certified copy thereof with the Secretary of State.
