

CERTIFICATE OF CONSENT BY THE STATE OF MINNESOTA
TO THE ACQUISITION OF LANDS BY THE UNITED STATES.

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, The Secretary of Agriculture of the United States, pursuant to the provisions of General Statutes of Minnesota of 1923, Sections 4 and 6, and to the acts of Congress hereinafter set forth, has made application for the consent of the State of Minnesota to the acquisition by the United States of the lands hereinafter described, which lands have been acquired by the United States under the authority of the Act of Congress of March 1, 1911 (36 Statutes at Large, page 961, Chapter 186), as amended by the Act of Congress of June 7, 1924, (43 Statutes at Large, page 653, Chapter 348), for certain national purposes therein specified, to-wit, for the regulation of the flow of navigable streams or for the production of timber or for other national purposes set forth in said acts.

AND WHEREAS, proof has been made that the title to said lands has duly vested in the United States;

NOW, THEREFORE, I, Floyd B. Olson, Governor of the State of Minnesota, pursuant to the authority vested in me by the statutes of the State of Minnesota aforesaid, certify that the State of Minnesota consents to the acquisition by the United States for the purposes aforesaid of the following described lands situated in the County of Beltrami, State of Minnesota, to-wit:




