AN ORDINANCE DETACHING CERTAIN AGRICULTURAL LANDS
FROM THE VILLAGE OF BLUFFTON

The Village Council of Bluffton, Otter Tail County, Minnesota do ordain as follows:

Sec. 1. Whereas a petition was, on the 31st day of Janu., 1910, filed with and presented to the Village Council of said Village of Bluffton, which petition was signed by more than thirty of the legal voters of said Village, and also by a majority of the owners of the agricultural lands mentioned therein and hereinafter described, in said Village, praying that all those tracts, pieces, or parcels of land named in said petition, and hereafter mentioned be set apart, separated and detached from said Village, pursuant to Chapter 460, General Laws, of Minnesota for the year 1909, and whereas an election was by said Council duly called for and held and conducted on the 23rd day of February, 1910, under said law, and a majority of the voters voting at said election, voted in favor of detaching said lands, ^{and} the whole thereof from said Village, and whereas the detachment of said territory will not reduce the number of inhabitants of said Village below the number now required by law for the incorporation thereof,

NOW THEREFORE, all those tracts, pieces or parcels of land, ^{being} wholly agricultural in their character, mentioned in said petition and hereinafter described, shall be and hereby are detached and separated from the said Village of Bluffton and shall from the taking effect hereof, be and form a part of the Township of Bluffton.

Sec. 2. The tracts, pieces or parcels of land mentioned in said petition and detached from said Village by virtue hereof, are described as follows:

The NW 1/4 of NE 1/4 and SW 1/4 of NE 1/4 of Sec 19, Town 135, Range 36.
The NE 1/4 of the NE 1/4 and the SE 1/4 of the NE 1/4, of the same section.
