of the Village of Biwabik and Annexing to said Village Certain Land Commonly Known as the C. J. Eklund Property.

** ** ** ** ** ** ** ** **

The Village Council of the Village of Biwabik, in St. Louis County, Minnesota, do ordain as follows:

SECTION 1. Annexation. -- Pursuant to and in conformity with section 707 of the Revided Laws of Minnesota, 1905, the present corporate limits and village boundaries of the Village of Biwabik, St. Louis County, Minnesota, are hereby extended so as to include all that piece and parcel of land outlined, bounded and described in Section 2 hereof and same is hereby annexed to, declared to be an addition to, and a part of the Village of Biwabik as effectually as if the same had been originally a part Mhereof.

SECTION 2. Description of Property. — The land hereby annexed being adjacent to and abutting upon the present corporate limits of the Village of Biwabik is described as follows to-wit;

That portion of the NW 1/4 of the NW 1/4 of Section 11, Township 58, Range 16, North of the 4th Principal Meridian, Saint Louis County, Minnesota, more specifically described, outlined and bounded as follows, to-wit; a strip of land on the extension of Canton Avenue commencing at a point one handred twenty-five (125) feet south of the SE corner of Block numbered fifty-five (55) of the Village of Biwabik according to the recorded plat thereof now on file and of record in the office of the Register of Deeds in and for St.Louis County, (mamely, at the SE corner of Outlot numbered two (2) of said Village), to make a direct continuation of the West Line of
