GOVERNOR'S ORDER NUMBER 20, EXTENDING PROTECTION TO DEER
IN CERTAIN COUNTIES AND PORTIONS OF COUNTIES IN THE STATE
OF MINNESOTA, DURING THE YEAR 1936.

* * * * *

Whereas, it has been represented to the Director of Game and Fish that deer are in danger of undue depletion in certain counties in the State of Minnesota, and

Whereas, the Director of Game and Fish has investigated and has presented me with the results of his investigation and has recommended that protection be given deer in all of the counties and portions of counties in the State of Minnesota, during the year 1936, except such counties and portions of counties as are listed below, to prevent their undue depletion:

Cook, Lake, St. Louis, Carlton, Pine, Kangbee, Koochiching, Itasca, Aitkin, Crow Wing, Cass, Hubbard, Clearwater, Beltrami, Lake of the Woods, Roseau; all of that portion of Kittson and Marshall Counties lying east of the old Pembina Trail running from the north boundary of Kittson County to the south boundary of Marshall County; all of that part of Becker County lying east of the Minneapolis, St. Paul and Scult Ste. Marie Railway tracks; all of that part of Mille Lacs County lying north of the Great Northern Railway track running through Milaca, Foreston and Beck;

1936 fawns only protected.

Itasca County open to the taking of antlered male deer only.

Now, therefore, I, Hjalmar Petersen, Governor of the State of Minnesota, by virtue of and pursuant to authority vested in me by Section 5640, G. S. 1935, do hereby order that no deer shall be taken in any counties or portions of counties during the season of 1936, except those counties and portions of counties listed herein.

This order shall remain in force until the close of the 1937 regular session of the Legislature of the State of Minnesota, unless sooner revoked or modified.
