At a regular meeting of the Board of County Commissioners of Lahnosen County, Minnesota, held April 27, 1906, Commissioner Lovin offered the following resolution and moved its adoption viz., "Whereas the date for hearing on the contemplated dissolution of Little Elbow Township in Lahnosen County, Minnesota, was set for April 27, 1906, at 11 o'clock A. M., and, Whereas due notice of said hearing was given to the Town Board of said Township, and, Whereas the County Auditor of Lahnosen County has filed his certificate showing: that said Little Elbow Township was duly organized on May 25, 1902; that the assessed valuation of said township including real and personal property and money & credits for the year 1905 is \$30,000.00; that the tax delinquency of said township, exclusive of taxes that are delinquent or unpaid by reason of taxes being collected in proceedings for the enforcement of taxes, amounts to \$31,286.35 as of April 27, 1906, and, Whereas all of the foregoing facts appear from the records in the office of the County Auditor of Lahnosen County, Minnesota, and have been and hereby are determined and found to be true by this board. Now Therefore, Be It Resolved, that said Town of Little Elbow in Lahnosen County, Minnesota, be, and hereby is dissolved and no longer entitled to exercise any of the powers or functions of an organized township, and, Be It Further Resolved, that the County Auditor of Lahnosen County, Minnesota, be, and be hereby is instructed to forthwith mail a certified copy of this resolution to the Secretary of State of Minnesota; and, Be It Further Resolved, that the territory of said disorganized township be and hereby is constituted one assessment district and one election district and that Glen Clark be and be hereby is appointed the assessor for said district and his compensation is hereby fixed at \$1.00 per day but not to exceed \$20.00 and his term of office shall be one year, and, Be It Further Resolved that the present voting place of said district be and hereby is constituted and continued as the voting place of said district".

Commissioner Barry seconded the motion for the adoption of the above resolution and the same being put to a vote, there were 4 ayes and 2 nays and the resolution was duly adopted.
