"Whereas the date for hearing on the contemplated dissolution of Twin lakes Township, in Mahnomen County, Minnesota, was set for March 29, 1937, at 2 o'clock P.M., and, Whereas, due notice of said hearing was given to the fown Board of said Twin Lakes Township, and, Whereas, the County Auditor of Mahnomen County, Minnesota, has filed his certificate showing: "That Twin Lakes Township was duly organized on the 1st day of June, 1920; that the assessed valuation of said township including real and personal property and moneys & credits for the year 1936 is \$28,566.00 after deducting the valuation of lands sold to the United States of America; that more than 50% of the lands in said Township have been sold and transferred to the United States of America", and, Whereas, all of the foregoing facts appear from the records in the office of the County Auditor of Mahnomen County, Minnesota, and have been and hereby are determined and found to be true by this board. Now Therefore, Be It Hereby Resolved, that said Town of Twin Lakes, comprising Township 144 North, Range 39 West of the 5th P.M., in Minnesota, be and hereby is dissolved and no longer entitled to exercize any of the pwoers or functions of an organized Township; and, be it hereby further resolved, that the County Auditor of Mahnomen County, Minnesota, be, and he hereby is instructed to forthwith mail a certified copy of this resolution to the Secretary of State of Minnesota; and, Be It Hereby Further Resolved that the territory of said unorganized township be and hereby is constituted one assessment district and one election district; and that Oscar Lee be and he hereby is appointed the assessor for said district and his compensation is hereby fixed at \$4.00 per day and his term of office shall be one year; and, be it further resolved that the present voting place of said district be and hereby is constituted and continued as the voting place of said district.

Motion was made by Commissioner Lovin to adopt the above resolution; same was seconded by Commissioner Barry and upon being put to a vote, there were 3 ayes and no nayes and the resolution was declared duly adopted.
