

ORDINANCE NO. 45.

An Ordinance providing for the annexing of certain territory to the Village of Walker on petition of Walker Commercial Club Association.

WHEREAS the Walker Commercial Club Association, a corporation, has presented to the Village Council of the Village of Walker a petition as follows:

"TO THE HONORABLE VILLAGE COUNCIL OF THE VILLAGE OF WALKER:

"The Walker Commercial Club Association, a corporation, of Walker, Cass County, Minnesota, respectfully represents that it is the owner of the following described unplatted land abutting upon the Village of Walker, to-wit: Lot two (2) in Section twenty three (23), in Township one hundred and forty two (142) North, of Range thirty one (31) West of the Fifth Principal Meridian in Minnesota; and respectfully petitions that said above described tract be annexed to and included within the corporate limits of said Village of Walker.

And whereas said village council has, by resolution duly passed, decided to grant said petition; now therefore,

THE VILLAGE COUNCIL OF THE VILLAGE OF WALKER DO ORDAIN AS FOLLOWS:

Section 1. That the following described unplatted land abutting upon the Village of Walker, to-wit: Lot two (2) in Section twenty three (23), in Township one hundred and forty two (142) North, of Range thirty one (31) West of the Fifth Principal Meridian in Minnesota, be and the same hereby is annexed to, included within and made a part of the incorporated Village of Walker.

Section 2. This ordinance shall be in force from and after its passage and publication and the filing of a certified copy thereof in the office of the Secretary of State of Minnesota.
