VILLAGE ORDINANCE

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARY OF THE VILLAGE OF COOLEY, ITASCA COUNTY, MINNESOTA SO AS TO INCLUDE WITH-IN THE VILLAGE AND TO ANNEX THERETO THE SOUTHWEST QUARTER OF THE MORTHWEST QUARTER, AND THE NORTH ONE-HALF OF THE SOUTHWEST QUARTER, THE NORTH ONE-HALF OF THE SOUTHWEST QUARTER, THE SOUTHWEST QUARTER OF THE MORTHWEST QUARTER, AND THE MORTHEAST QUARTER OF THE MORTHWEST QUARTER, AND THE MORTHEAST QUARTER OF THE MORTHWEST QUARTER ALL IN SECTION ELEVEN, TOWNSEIP FIFTY-SIX NORTH OF RANGE TWENTY-THREE WEST OF THE FOURTH PRINCIPAL MERIDIAN IN ITASCA COUNTY, MINNESOTA.

The Village Council of the Village of Cooley in Itasca County, Minnesota, do ordain as follows:

SECTION I.

The owners of the Southwest Quarter of the Northwest Quarter (SW1 of NW1) and the North One-half of the Southwest Quarter (N1 of SW1), the North One-half of the Southwest Quarter (N2 of SW1), the Southwest Quarter of the Northeast Quarter (SW1 of NW1), the Southeast Quarter of the Northwest Quarter (SW1 of NW1) and the Northeast Quarter of the Northwest Quarter (NE1 of NW1) all in Section Eleven (11) Township Fifty-six (56) North of Range Twenty-three (23) West of the Fourth Principal Meridian in Itasca County, Minnesota which is unplatted land and which land abuts upon the present limits of the Village of Cooley having petitioned the Village Council of the Village and annexed thereto;

It is hereby ordained, enacted and declared that said tracts of land above described be and the same are hereby annexed to the said Village of Cooley, and the boundaries and corporate limits of said Village of Cooley are hereby extended so as to include said tracts of land, and said lands shall be and become a part of said Village as effectually as if they had been originally a part thereof.

SECTION II.

This ordinance shall take effect and be in force from and after its passage and publication and the filing of a certified copy thereof with the Secretary of State.
