

VILLAGE ORDINANCE

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARY OF THE VILLAGE OF COOLEY, ITASCA COUNTY, MINNESOTA SO AS TO INCLUDE WITHIN THE VILLAGE AND TO ANNEX THERETO THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER, AND THE NORTH ONE-HALF OF THE SOUTHEAST QUARTER, THE NORTH ONE-HALF OF THE SOUTHWEST QUARTER, THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER, THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER, AND THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER ALL IN SECTION ELEVEN, TOWNSHIP FIFTY-SIX NORTH OF RANGE TWENTY-THREE WEST OF THE FOURTH PRINCIPAL MERIDIAN IN ITASCA COUNTY, MINNESOTA.

The Village Council of the Village of Cooley in Itasca County, Minnesota, do ordain as follows:

SECTION I.

The owners of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$) and the North One-half of the Southeast Quarter (N $\frac{1}{2}$ of SE $\frac{1}{4}$), the North One-half of the Southwest Quarter (N $\frac{1}{2}$ of SW $\frac{1}{4}$), the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$), the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$) and the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) all in Section Eleven (11) Township Fifty-six (56) North of Range Twenty-three (23) West of the Fourth Principal Meridian in Itasca County, Minnesota which is unplatted land and which land abuts upon the present limits of the Village of Cooley having petitioned the Village Council of the Village of Cooley to have said lands included within said Village and annexed thereto;

It is hereby ordained, enacted and declared that said tracts of land above described be and the same are hereby annexed to the said Village of Cooley, and the boundaries and corporate limits of said Village of Cooley are hereby extended so as to include said tracts of land, and said lands shall be and become a part of said Village as effectually as if they had been originally a part thereof.

SECTION II.

This ordinance shall take effect and be in force from and after its passage and publication and the filing of a certified copy thereof with the Secretary of State.




