

ORDINANCE NO. 83.

An ordinance extending the boundary lines of the Village of Le Center, Minnesota, so as to include in said Village, Lots numbered twenty three (23) and twenty four (24), Block four (4), Center Park Addition to Le Center, and making said described lots a part of said Village.

The Village Council of Le Center, Minnesota does ordain as follows:--

1.
That Lots twenty three (23) and twenty four (24), in Block four, (4), Center Park Addition to the Village Of Le Sueur Center, now Le Center, Minnesota, said lots lying and abutting upon said Village, are hereby included within said Village.

2.
The boundary lines of said Village of Le Center, Minnesota, are hereby enlarged to cover that part of Solberg Avenue, and the lots in the heading hereof, with the adjacent streets and alleys.

This ordinance shall take effect from and after its passage and publication.
