JULY 7, RELATIVE TO PETITION
FOR SPECIAL ELECTION

A delegation from the Village of Okabena came before the Board and presented a petition asking that the Board call a special election to vote on the question of whether or not the following described territory should be incorporated as a Village, to be known as the Village of Okabena.

The South Half of the Northeast Quarter ($S\frac{1}{2}NE\frac{1}{4}$) and the North Half of the Southeast Quarter ($N\frac{1}{2}SE\frac{1}{4}$) of Section Seven (7) and the West Half of the Southwest Quarter ($W\frac{1}{2}SW\frac{1}{4}$) of the Northwest Quarter ($NW\frac{1}{4}$) and the West Half of the Northwest Quarter of the Southwest Quarter ($W\frac{1}{2}NW\frac{1}{4}SW\frac{1}{4}$) of Section Eight (8) all in Township One Hundred Three (103) North, Range Thirty-seven (37) West of the Fifth Principal Meridian in Jackson County, Minnesota.

Said petition having been found in proper and legal form, a motion was made and carried approving said petition.


On motion made and carried, Wednesday, July 6, 1938, was fixed as the date for said special election to be held in the West Heron Lake Township Hall in the Village of Okabena, and the County Auditor was directed to cause notices to be posted and published as required by law.

On motion made and carried, the following persons were appointed as Judges of said election: Wm. Ikier, Sidney M. Dahl, and D. D. Rempel.

Come now the undersigned voters residing within the territory herein proposed to be incorporated and hereinafter more fully described, and petition your Honorable Board to call an election for the determination of such proposed incorporation. Your petitioners represent and state that they first caused to be taken a census of the resident population of the territory within the proposed incorporation and found the same to contain more than the minimum required by law. The boundary of the territory proposed to be incorporated is within a line described as commencing at the Southwest corner of the North Half of the Southeast Quarter (SW corner of N $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Seven (7), running thence North One Hundred Sixty rods (160) to the Northwest corner of the South Half of the Northeast Quarter (NW corner of S $\frac{1}{2}$ NE $\frac{1}{4}$) of Section Seven (7), thence East Two Hundred (200) rods to the Northeast corner of the West Half of the Southwest Quarter (NE corner of W $\frac{1}{2}$ SW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Eight (8), thence South One Hundred Sixty (160) rods to the Southeast corner of the West Half of the Northwest Quarter of the Southwest Quarter (SE corner of W $\frac{1}{2}$ of NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Eight (8), thence West Two Hundred rods (200) to the place of beginning, all in Township One Hundred Three (103) North, Range Thirty-seven (37) West of the Fifth Principal Meridian in Jackson County, Minnesota.
