In case of loss or injury to any part of the insured property consisting, when complete for sale or use, of several parts, this Company shall only be liable for the insured value of the part lost or damaged.



The Bureau, in consideration of the payment to be made for the service, will call at the office of the Secretary of State in the State Japitol Building, at St. Paul, at eleven o'clock in the morning of each banking day during the time this agreement is in effect, with an armoured car accompanied by guards, and will receive and escort from the cashier's office of the motor vehicle department to said van, and transport therein from the Capitol Building to the First National Bank or to the Empire National Bank both of St. Paul, the messenger employed by the Secretary of State to take to and deposit in that bank the money and other cash items received in payment of motor vehicle taxes, and while this messenger and moneys and other cash items are in the possession of the messenger while being so escorted and transported will guarantee safe conduct of the messenger and moneys and other cash items in his possession, and will make good to the State any loss it may sustain through its failure to keep this condition, with the understanding, however, that the obligation of the Bureau to make good such loss shall not exceed one hundred thousand dollars in any instance.

The responsibility of the Bureau for the safeguarding of the funds in the possession of the messenger shall commence when the messenger of the Secretary of State leaves the cashier's office under the protection of the guards supplied by the Bureau, and shall terminate when the messenger arrives with his deposit at the teller's window in the bank.
