AN ORDINANCE PROVIDING FOR THE ANNEXATION AND ADDITION OF CERTAIN TERRITORY HEREINAFTER DESCRIBED TO THE VILLAGE OF WALTERS, PARIBAULT COUNTY, MINNESOTA.

THE VILLAGE COUNCIL Of the Village of Walters do ordain as follows:

Sec. 1.
