TO: THE HONORABLE COUNTY BOARD OF BELTRANI COUNTY, MINNESOTA

The undersigned respectfully represent and show as follows:

That the undersigned desire to incorporate as a village. pursuant to Section 1111 to 1115, inclusive, of Mason's Minnesota General Statutes for 1927, that certain territory situated in Beltrami County, Minnesota, which lies within the following boundaries to-wit:

Commencing at the one-sixteenth corner number four (4). section twenty-eight (28), township one hundred forty-seven (147) North, range thirty-three (33) West:

Thence northerly along the sixteenth lines approximately thirty-nine hundred sixty (3960) feet to the one-sixteenth corner number ten (10), section twenty-one (21), township one hundred forty-seven (147) North, range thirty-three (33) West;

Thence easterly along the one-sixteenth line approximately thirteen hundred twenty (1320) feet to one-sixteenth corner number nine (9);

Thence northerly along the quarter line approximately twentysix hundred (2600) feet to the one-guarter corner common to sections sixteen (16) and twenty-one (21), township one hundred forty-seven (147) North, range thirty-three (33) West:

Thence easterly along the section line approximately eleven hundred (1100) feet to the northerly boundary line of State Rural Highway No. 9-B, which was for a time designated as temporary State Trunk Highway No. 4, as said Highway is located and shown on Auditor's Plat No. 10:

Thence northeasterly along the northerly boundary of said State Rural Highway No. 9-B, approximately sixteen hundred twenty (1620) feet to the extended east line of Lot "A" of Auditor's Plat No. 10; 8830

Thence coutherly along the east line of said Lot "A" approximately four hundred eighty (480) feet to the low water mark of Lake Bemidji;

Thence southwesterly and southerly along the low water mark of Lake Bemidji approximately eighty-six hundred (8600) feet to the southeast corner of Government Lot No. one (1), section twenty-eight (28), township one hundred forty-seven (147) North, range thirty-three (33) West;

Thence westerly along the one-sixteenth line approximately twenty- six hundred (2600) feet to the point of beginning and there ending.

II

That a portion of said premises has been platted into lots and blocks; that the plats thereof have been duly and legally certified according to the laws of this state and have been duly filed for record in the office of the Register of Deeds in and for said county; that the unplatted portions of the premises lying within the boundaries above specified adjoin and lie adjacent to said platted portions.

III

That all of said territory, including both the platted and unplatted portion thereof, is so conditioned as to be properly subjected to village government.

IV

That all of said territory lies within Beltrami County, Minnesota, and that no part or portion thereof lies within any incorporated village or city.

That each of the undersigned resides within the territory hereby asked to be incorporated and is a qualified voter therein.

That an accurate census of the resident population of said territory was duly taken on August 15, 1940, and that the actual resident population then was, and now is, one hundred and thirty-five (135) persons. That the quantity of land embraced within the boundary lines above specified, and within the territory herein acked to be incorporated, in approximately two hundred fifty (250) acres, more or less, according to the government surveys thereof and on file in the Register of Deeds office in and for Beltrami County, Minnesota.

VIII

That the name of the proposed village shall be "North Pole".

WHEREFORE, your petitioners pray that the county board of said B_{e} ltrami County approve this petition; that it shall call an election for determination of the incorporation herein proposed; that it fix a time and place for holding such election; that it cause proper notice of this petition and of such election to be given, and that said board appoint three inspectors who are residents of said territory to act as judges for said election.
